(Conspiracy - Second Degree)

KIAN BARBER

KASIM WILLIAMS

AND

TYSHAD HAWKINS

who are named as defendants herein, and other persons whose identities are both known and unknown to the Grand Jurors, who are named as co-conspirators but not as defendants herein, between on or about May 29, 2020, and on or about September 9, 2020, at the City of Newark, in the County of Essex, in the City of Philadelphia, in the State of Pennsylvania, in the City of Baltimore, in the State of Maryland, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crimes of Receiving Stolen Property and Fencing-Dealing in Stolen Property, did agree together that:

A. One of more of them would knowingly engage in conduct which would constitute the aforesaid crimes; or

between on or about May 29, 2020, and on or about September 9, 2020, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, did commit theft by knowingly receiving or bringing into this State moveable property of others, that is, motor vehicles, having a value in excess of \$500.00, knowing the same to be stolen or believing that they had probably been stolen, contrary to the provisions of <u>N.J.S.A.</u> 2C:20-7, <u>N.J.S.A.</u> 2C:20-2, <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Attempted Theft by Unlawful Taking - Second Degree)

DAVID MANNING

on or about July 1, 2020, in the Borough of Point Pleasant, in the County of Ocean, elsewhere, and within the jurisdiction of this Court, knowingly did attempt to unlawfully take or exercise control over moveable property of another, that is, a motor vehicle, having a value in excess of \$75,000.00, with the purpose to deprive the owner thereof, contrary to the provisions of <u>N.J.S.A.</u> 2C:5-1, <u>N.J.S.A.</u> 2C:20-3a, <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Escape from Detention - Third Degree)

KASIM WILLIAMS

on or about September 23, 2020, at the City of East Orange, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly did without lawful authority remove himself from official detention, contrary to the provisions of <u>N.J.S.A.</u> 2C:29-5, and against the peace of this State, the government and dignity of the same.
