Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

This case involves Frank Blake a/k/a "Lafay" a/k/a "Fay" ("Blake"), a leader of the Almighty Latin King Queen Nation ("ALKQN") Elizabeth chapter as well as multiple ALKQN inmates under his command. Blake is currently on Gang Parole Supervision until on or about March 31, 2023. Complaint Warrant W-1111-2021-001117 previously charged Blake for his role in directing an assault on or about September 28, 2020, in which ALKQN members Roberto Garcia and Eduardo Lago assaulted an inmate with the initials K.S. in the prison yard at New Jersey State Prison, resulting in a traumatic brain injury and acute respiratory failure for K.S. A review of jail calls showed that the assault occurred after William Figueroa requested Blake direct Garcia and Lago to commit the assault. Additionally, a review of jail calls made between in or around December 2020 and February 2021 revealed that Blake conspired with and directed ALKQN members Kevin Washington, Alexander Chludzinski, Andy Reyes, Roberto Garcia, James Zarate, and Larry Cardona to locate and/or assault an inmate with the initials D.K., an individual he previously pleaded guilty to assaulting. NJDOC placed D.K. in protective custody to forestall this attempted assault. Finally, a review of jail calls revealed Blake threatened SID Investigators, discussing visiting their houses in order to intimidate and/or commit violence, including mentioning at least one by name, and discussing ALKQN gang authorization for assaults on SID members attempting to take ALKQN inmates for interviews. On or about April 21, 2021, law enforcement effectuated search warrants upon [REDACTED] Hillside, New Jersey and a car associated with Blake. At that time, law enforcement arrested Blake in the residence. A search of the house revealed items including but not limited to the following: 44 .45 caliber pistol rounds, 1 Springfield XDE .45 Caliber pistol (Serial Number HE111585) with 1 magazine and 6 .45 Caliber rounds, 1 ALKQN Manifesto, 1 ALKQN New Jersey Lion Tribe Manifesto, 1 Ruger Security Six .357 Caliber revolver (Serial Number 154-52137) loaded with 6 hollow-point .38 Caliber rounds, 91 glass jars with black lids, 1 medication bottle bearing Blake's name containing 5 .38 Caliber hollow point rounds, 1 SCCY Industries CPX-2 9mm pistol with 1 magazine and 11 9mm rounds, 1 22 round Glock magazine with 20 .40 Caliber rounds, 6 containers filled with numerous pills believed to be CDS Methamphetamine and 2 digital scales and 1 body armor vest
