## COUNT ONE

(Unlawful Possession of a Firearm - Second Degree)

#### VICTOR TORRES

on or about September 20, 2020, at the Township of Hamilton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a .40 caliber S&W Taurus semi-automatic pistol, serial number SMR11704, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.
