The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Unlawful Possession of an Assault Firearm - Second Degree)

CHRISTOPHER PESPAS

on or about August 28, 2019, at the Township of Egg Harbor, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, knowingly did have in his possession an assault firearm, or any combination of parts from which an assault firearm may be readily assembled, contrary to the provisions of N.J.S.A. 2C:39-5f, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Unlawful Possession of an Assault Firearm - Second Degree)

CHRISTOPHER PESPAS

on or about August 28, 2019, at the Township of Egg Harbor, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, knowingly did have in his possession an assault firearm, or any combination of parts from which an assault firearm may be readily assembled, contrary to the provisions of N.J.S.A. 2C:39-5f, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Unlawful Possession of an Assault Firearm - Second Degree)

CHRISTOPHER PESPAS

on or about August 28, 2019, at the Township of Egg Harbor, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, knowingly did have in his possession an assault firearm, or any combination of parts from which an assault firearm may be readily assembled, contrary to the provisions of N.J.S.A. 2C:39-5f, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Purchasing Firearm Parts to Manufacture a Firearm Without a
Serial Number - Third Degree)

CHRISTOPHER PESPAS

on or about August 28, 2019, at the Township of Egg Harbor, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, did, with the purpose to manufacture or otherwise assemble a firearm, and without being registered or licensed to manufacture a firearm pursuant to chapter 58 of Title 2C of the New Jersey Statutes, purchase or obtain separately or as part of a kit a firearm frame or firearm receiver which is not imprinted with a serial number registered with a federally licensed manufacturer, or any combination of parts from which a firearm without a serial number may be readily manufactured or otherwise assembled, but which does not have the capacity to function as a firearm unless manufactured or assembled, contrary to the provisions of N.J.S.A. 2C:39-9k, and against the peace of this State, the government and dignity of the same.


COUNT FIVE

(Unlawful Possession of a Large Capacity Ammunition Magazine -
Fourth Degree)

ammunition magazine, contrary to the provisions of N.J.S.A. 2C:39-
3j, and against the peace of this State, the government and dignity
of the same.
