The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Possession of a Controlled Dangerous Substance - Third Degree)

DAEVON BELL

on or about December 27, 2019, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess a controlled dangerous substance, that is, heroin, a Schedule I controlled dangerous substance, contrary to the provisions of N.J.S.A. 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Possession with Intent to Distribute a Controlled Dangerous Substance - Third Degree)

DAEVON BELL

on or about December 27, 2019, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess with intent to distribute a controlled dangerous substance, that is, heroin, contrary to the provisions of N.J.S.A. 2C:35-5a(1), N.J.S.A. 2C:35-5b(3), and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Unlawful Possession of a Weapon - Second Degree)

DAEVON BELL

on or about December 27, 2019, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a Glock 22 semi-automatic handgun, serial number GPS0170, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Unlawful Possession of a Weapon - Second Degree)

DAEVON BELL

on or about December 27, 2019, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a Glock 21 semi-automatic handgun, identification number NJ192075, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.

Count Five

(Possession of a Firearm During the Commission of Certain Crimes - Second Degree)

DAEVON BELL

on or about December 27, 2019, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon(s), that is, a Glock 22 semi-automatic handgun, serial number GPS0170, and/or a Glock 21 semi-automatic handgun, identification number NJ192075, while in the course of committing or attempting to commit a violation of N.J.S.A. 2C:35-5a(1), contrary to the provisions of N.J.S.A. 2C:39-4.1a, and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Possession of Hollow Nose Bullets - Fourth Degree)

DAEVON BELL

on or about December 27, 2019, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon or device, that is hollow nose bullets, contrary to the provisions of N.J.S.A. 2C:39-3f, and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Unlawful Possession of a Large Capacity Ammunition Magazine - Fourth Degree)

DAEVON BELL

on or about December 27, 2019, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine, contrary to the provisions of N.J.S.A. 2C:39-3j, and against the peace of this State, the government and dignity of the same.

COUNT EIGHT

(Possession of a Defaced Firearm - Fourth Degree)

DAEVON BELL

on or about December 27, 2019, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did have in his possession a prohibited weapon, that is, a Glock 21 semi-automatic pistol with a defaced serial number, contrary to the provisions of N.J.S.A. 2C:39-3d, and against the peace of this State, the government and dignity of the same.

COUNT NINE

(Certain Persons Not to Have Weapons - Second Degree)

DAEVON BELL

on or about December 27, 2019, at the City of Trenton, in the County

of Mercer, elsewhere, and within the jurisdiction of this Court,

having been convicted of the crimes of Second Degree Unlawful

Possession of a Handgun in Mercer County, on Indictment number

MER130901107I; and/or Third Degree Distribution/Possession with

Intent to Distribute a Controlled Dangerous Substance in Mercer

County, on Indictment number MER140500531I; and/or Second Degree

Distribution/Possession with Intent to Distribute a Controlled

Dangerous Substance in Mercer County, on Indictment number

MER1503003771, did purchase, own, possess or control the following

firearm(s): a Glock 22 semi-automatic handgun, serial number

GPS0170, and/or a Glock 21 semi-automatic handgun, identification
