The Grand Jurors of and for the State of New Jersey,  
upon their oaths, present that:

COUNT ONE

(Unlawful Possession of a Handgun - Second Degree)

DAVON MCCLENDON

on or about October 27, 2020, at the City of Atlantic City, in the  
County of Atlantic, elsewhere, and within the jurisdiction of this  
Court, knowingly did possess a handgun, that is, a GSG Firefly .22  
semi-automatic pistol, serial number F387536, without first having  
obtained a permit to carry same as provided in N.J.S.A. 2C:58-4,  
contrary to the provisions of N.J.S.A. 2C:39-5B(1), and against  
the peace of this State, the government and dignity of the same.

COUNT TWO

(Possession of a Weapon while in the Process of Committing a CDS  
Offense - Second Degree)

DAVON MCCLENDON


on or about October 27, 2020, at the City of Atlantic City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, knowingly possessed a firearm, specifically a GSG Firefly .22 semi-automatic pistol, serial number F387536, while in the course of committing, attempting to commit, or conspiring to commit a violation N.J.S.A. 2C:35-5b(2), contrary to the provisions of N.J.S.A. 2C:39-4.1A, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Certain Person Not to Have Weapons - Second Degree)

DAVON MCCLENDON

on or about October 27, 2020, at the City of Atlantic City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, having been convicted of the crime of Third Degree Aggravated Assault - Attempt to Cause Significant Bodily Injury in Cumberland County, on Accusation number 16-06-00525-A, did purchase, own, possess, or control the following firearm: GSG Firefly .22 semi-automatic pistol, serial number F387536, contrary to the provisions of N.J.S.A. 2C:39-7b(1), and against the peace of this State, the government, and dignity of the same.
