The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Unlawful Possession of a Weapon - Second Degree)

ENRIQUE ALFONSO

on or about February 28, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a 9 mm Millennium handgun, model number PT111G2, serial number TKM52355, without having first obtained a permit to carry same as provided in <u>N.J.S.A.</u> 2C:58-4, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Unlawful Possession of a Large Capacity Ammunition Magazine - Fourth Degree)

ENRIQUE ALFONSO

on or about February 28, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-3j, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Manufacture, Transport, Disposition of a Weapon - Fourth Degree)

ENRIQUE ALFONSO

on or about February 28, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did transport, ship, sell, or dispose of a firearm, that is, a 9mm Millennium handgun, model number PT111G2, serial number TKM52355, without being licensed or registered to do so as provided in Chapter 58, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-9d, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Manufacture, Transport, Disposition of a Large Capacity Ammunition Magazine - Fourth Degree)

ENRIQUE ALFONSO

on or about February 28, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did transport, ship, sell, or dispose of a large capacity ammunition magazine, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-9h, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Unlawful Possession of a Weapon - Second Degree)

ENRIQUE ALFONSO

on or about March 9, 2020, at the City of Camden, in the County of Camden, elsewhere and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a .44 caliber Ruger Super Redhawk revolver, serial number 55071400, without having first obtained a permit to carry same as provided in <u>N.J.S.A.</u> 2C:58-4, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Unlawful Possession of a Rifle - Third Degree)

ENRIQUE ALFONSO

on or about March 9, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did possess a firearm, that is, a 5.56 caliber Romarm Rifle, serial number 31364886, without having first obtained a firearms purchaser identification card in accordance with the provisions of $\underline{N.J.S.A.}$ 2C:58-3, contrary to the provisions of $\underline{N.J.S.A.}$ 2C:39-5c(1), and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Unlawful Possession of a Large Capacity Ammunition Magazine - Fourth Degree)

ENRIQUE ALFONSO

on or about March 9, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-3j, and against the peace of this State, the government and dignity of the same.

COUNT EIGHT

(Manufacture, Transport, Disposition of a Weapon - Fourth Degree)

ENRIQUE ALFONSO

on or about March 9, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did transport, ship, sell, or dispose of a firearm, that is, a .44 caliber Ruger Super Redhawk revolver, serial number 55071400, without being licensed or registered to do so as provided in Chapter 58, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-9d, and against the peace of this State, the government and dignity of the same.

COUNT NINE

(Manufacture, Transport, Disposition of A Firearm - Fourth Degree)

ENRIQUE ALFONSO

on or about March 9, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did transport, ship, sell, or dispose of a firearm, that is, a 5.56 caliber Romarm Rifle, serial number 31364886, without being licensed or registered to do so as provided in Chapter 58, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-9d, and against the peace of this State, the government and dignity of the same.

COUNT TEN

(Manufacture, Transport, Disposition of a Large Capacity Ammunition Magazine - Fourth Degree)

ENRIQUE ALFONSO

on or about March 9, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did transport, ship, sell, or dispose of a large capacity ammunition magazine, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-9h, and against the peace of this State, the government and dignity of the same.

COUNT ELEVEN

(Unlawful Possession of a Weapon - Second Degree)

ENRIQUE ALFONSO

on or about March 24, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a .22 caliber Chrome and Brown Jennings handgun, serial number 478413, and/or a .380 caliber Ruger pistol, serial number 371321240, and/or a .22 caliber RTS revolver, serial number 116877, without having first obtained a permit to carry same as provided in <u>N.J.S.A.</u> 2C:58-4, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT TWELVE

(Manufacture, Transport, Disposition of a Weapon - Fourth Degree)

ENRIQUE ALFONSO

on or about March 24, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did transport, ship, sell, or dispose of a firearm, that is, a .22 caliber Chrome and Brown Jennings handgun, serial number 478413, and/or a .380 caliber Ruger pistol, serial number 371321240, and/or a .22 caliber RTS revolver, serial number 116877, without being licensed or registered to do so as provided in Chapter 58, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-9d, and against the peace of this State, the government and dignity of the same.

COUNT THIRTEEN

(Unlawful Possession of an Assault Firearm - Second Degree)

ENRIQUE ALFONSO

on or about May 5, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did have in his possession an assault firearm, that is, a MasterPiece Arms Mac 10 Pistol, serial number FX08768, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-5f, and against the peace of this State, the government and dignity of the same.

COUNT FOURTEEN

(Unlawful Possession of a Large Capacity Ammunition Magazine - Fourth Degree)

ENRIQUE ALFONSO

on or about May 5, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-3j, and against the peace of this State, the government and dignity of the same.

COUNT FIFTEEN

(Manufacture, Transport, Disposition of an Assault Firearm - Third Degree)

ENRIQUE ALFONSO

on or about May 5, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did transport, ship, sell, or dispose of an assault firearm, that is, a MasterPiece Arms Mac 10 Pistol, serial number FX08768, without having been registered or licensed to do so pursuant to <u>N.J.S.A.</u> 2C:58-1 <u>et</u>. <u>seq</u>., contrary to the provisions of <u>N.J.S.A.</u> 2C:39-9g, and against the peace of this State, the government and dignity of the same.

COUNT SIXTEEN

(Manufacture, Transport, Disposition of a Large Capacity Ammunition Magazine - Fourth Degree)

ENRIQUE ALFONSO

on or about May 5, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did transport, ship, sell, or dispose of a large capacity ammunition magazine, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-9h, and against the peace of this State, the government and dignity of the same.

COUNT SEVENTEEN

(Certain Persons Not to Have Weapons - Second Degree)

ENRIQUE ALFONSO

between on or about February 28, 2020, and on or about May 5, 2020, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, having been convicted of the crime of third degree Distribution of a Controlled Dangerous Substance within 1,000 Feet of School Property in Camden County, on accusation number CAM-110-400773A, did purchase, own, possess, or control the following firearm(s): a 9 mm Millennium handgun, model number PT111G2, serial number TKM52355; and/or a .44 caliber Ruger Super Redhawk revolver, serial number 55071400; and/or a 5.56 caliber Roman Arms submachine gun, serial number 31364886; and/or a .22 caliber Chrome and Brown Jennings handgun, serial number 478413; and/or a .380 caliber Ruger pistol, serial number 371321240; and/or a .22 caliber RTS revolver, serial number 116877; and/or a MasterPiece Arms Mac 10 submachine gun, serial number FX08768, contrary to the provisions of N.J.S.A. 2C:39-7, and against the

peace of this State, the government and dignity of the same.
