The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Possession of a Controlled Dangerous Substance - Third Degree)

ERIC CARR

on or about September 21, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess a controlled dangerous substance, that is, cocaine, a Schedule II controlled dangerous substance, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Distribution of a Controlled Dangerous Substance - Third Degree)

ERIC CARR

on or about September 21, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did distribute a controlled dangerous substance, that is, cocaine, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-5a(1) and <u>N.J.S.A.</u> 2C:35-5b(3), and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Distribution of a Controlled Dangerous Substance Within 1000 Feet of School Property - Third Degree)

ERIC CARR

on or about September 21, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did distribute a controlled dangerous substance, that is, cocaine, in violation of <u>N.J.S.A.</u> 2C:35-5a, while within 1000 feet of Woodrow Wilson Elementary School, which is owned by or leased to the Trenton Board of Education and used of school purposes, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-7, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Distribution of a Controlled Dangerous Substance Within 500 Feet of Certain Public Property - Second Degree)

ERIC CARR

on or about September 21, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did distribute a controlled dangerous substance, that is, cocaine, in violation of <u>N.J.S.A.</u> 2C:35-5a, while within 500 feet of Hetzel Field Park, a public park, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-7.1, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Possession of a Controlled Dangerous Substance - Third Degree)

ERIC CARR

on or about October 2, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess a controlled dangerous substance, that is, cocaine, and/or fentanyl, and/or oxycodone, a Schedule II controlled dangerous substance, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Possession with Intent to Distribute a Controlled Dangerous Substance - Second Degree)

ERIC CARR

on or about October 2, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess with the intent to distribute a controlled dangerous substance, that is, cocaine, in a quantity of one-half ounce or more but less than five ounces, including any adulterants or dilutants, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-5a(1) and <u>N.J.S.A.</u> 2C:35-5b(2), and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Possession with Intent to Distribute a Controlled Dangerous Substance - Third Degree)

ERIC CARR

on or about October 2, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess with intent to distribute a controlled dangerous substance, that is, fentanyl, a Schedule II narcotic drug, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-5a(1) and <u>N.J.S.A.</u> 2C:35-5b(5), and against the peace of this State, the government and dignity of the same.

COUNT EIGHT

Possession of a Firearm During the Commission of Certain Crimes - Second Degree)

ERIC CARR

on or about October 2, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a .45 caliber semi-automatic pistol, identification number NJ201910, while in the course of committing or attempting to commit a violation of <u>N.J.S.A.</u> 2C:35-5a; contrary to the provisions of <u>N.J.S.A.</u> 2C:39-4.1a, and against the peace of this State, the government and dignity of the same.

COUNT NINE

(Unlawful Possession of a Firearm without a Serial Number - Third Degree)

ERIC CARR

on or about October 2, 2020, at the City Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a firearm manufactured or otherwise assembled using a firearm frame or firearm receiver, as defined in <u>N.J.S.A.</u> 2C:39-9k, which was not imprinted with a serial number registered with a federally licensed manufacturer, that is, a .45 caliber semi-automatic pistol, identification number NJ201910, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-3n, and against the peace of this State, the government and dignity of the same.

COUNT TEN

(Unlawful Possession of a Large Capacity Ammunition Magazine - Fourth Degree)

ERIC CARR

on or about October 2, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-3j, and against the peace of this State, the government and dignity of the same.

COUNT ELEVEN

(Unlawful Possession of a Large Capacity Ammunition Magazine - Fourth Degree)

ERIC CARR

on or about November 19, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-3j, and against the peace of this State, the government and dignity of the same.

COUNT TWELVE

(Certain Persons Not to Have Weapons - Second Degree)

ERIC CARR

between on or about October 2, 2020, and on or about November 19, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, having been convicted of the crime of Second Degree Robbery in Mercer County, on Indictment number MER081201749I, did purchase, own, possess, or control the following firearm: a .45 caliber semi-automatic pistol, identification number NJ201910, and/or a Taurus G3 semiautomatic pistol, serial number ABE631549, contrary to the provisions of N.J.S.A. 2C:39-7b, and against the peace of this State, the government and dignity of the same.
