

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who

committed it: *****CONTINUATION FROM COMPLAINT SUMMONS 1025 S 2021 000031*****

FASCHAN LATER SUBMITTED A SPECIAL CUSTODY REPORT WHICH FALSELY CLAIMED THAT HE FILMED VICTIM 1 INFLICTING INJURIES UPON HERSELF. BY FILING A FALSE REPORT, FASCHAN INTENDED TO DECEIVE OTHERS WITHIN THE DOC INTO BELIEVING THAT THE FORCEABLE CELL EXTRACTION OF VICTIM 1 WAS JUSTIFIED AND THAT THE INJURIES SHE RECEIVED WERE SELF-INFLICTED. FASCHAN WAS ALSO RESPONSIBLE FOR FILMING THE EXTRACTION OF VICTIM 2. PEPPER SPRAY WAS DEPLOYED INTO VICTIM 2'S CELL. VICTIM 2 WAS NOT HANDCUFFED AT THAT TIME. THE CORRECTIONS OFFICERS DID NOT GIVE VICTIM 2 THE TIME REQUIRED TO COMPLY, AS REQUIRED BY DOC CUSTODY DIRECTIVE 33, IV(F). DOC OFFICERS THEN ENTERED VICTIM 2'S CELL TO FORCIBLY REMOVE HER. DURING THE EXTRACTION, AN OFFICER STRUCK VICTIM 2 IN THE FACE WITH A CLOSED FIST APPROXIMATELY 28 TIMES, EVEN THOUGH VICTIM 2 WAS NOT RESISTING. VICTIM 2 SUSTAINED INJURIES DURING THE CELL EXTRACTION, INCLUDING A CONCUSSION. FASCHAN DID NOT INTERVENE TO STOP THE OFFICERS' IMPROPER USE OF FORCE, WHICH VIOLATED DOC POLICIES THAT ONLY ALLOW FOR THE OBJECTIVELY REASONABLE AND NECESSARY USE OF FORCE. DESPITE HIS ROLE AS A RECORDING SERGEANT OF THE EXTRACTION TEAM, HIS PRESENCE IN VICTIM 2'S CELL, AND HIS OBSERVATION OF THE EXTRACTION, FASCHAN FAILED TO REPORT THE UNAUTHORIZED USE OF FORCE AGAINST AN INMATE, WHO WAS NOT RESISTING.

ACCORDING TO REPORTS, ON JANUARY 12, 2021 AT APPROXIMATELY 12:07 A.M., A FIVE (5) PERSON SUITED TEAM COMPRISED OF CO'S FROM EMCFW PERFORMED A CELL EXTRACTION FOR INMATE 2, WHO IS HOUSED IN THE RHU. DURING THE CELL EXTRACTION, INMATE 2 WAS PEPPER SPRAYED SECONDS BEFORE THE EXTRACTION TEAM ENTERED THE CELL AND INMATE 2 IS SEEN STANDING TOWARDS THE LEFT SIDE OF HER CELL ON VIDEO SURVEILLANCE. IMMEDIATELY UPON ENTERING THE CELL OF INMATE 2, CO PUNCHES AND STRIKES INMATE 2 WITH A CLOSED FIST APPROXIMATELY 28 TIMES IN THE FACE AREA, ALTHOUGH INMATE 2 HAS HER ARMS UP, ATTEMPTING TO COVER HER FACE, AND WHILE STANDING PRESSED UP AGAINST A WALL WITH HER BACK FACING THE OFFICERS, OR ATTEMPTING TO PROTECT HERSELF. DOC POLICY ONLY PERMITS USE OF FORCE THAT IS OBJECTIVELY NECESSARY AND REASONABLE. EXCESSIVE OR UNREASONABLE FORCE VIOLATES DOC CUS.001.UOF.002, IIIA. CO'S USE OF FORCE AGAINST INMATE 2 RESULTED IN SERIOUS BODILY INJURIES, INCLUDING CONCUSSION AND FACIAL INJURIES.
