The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Conspiracy - First Degree)

ISIAH GREENE

and

JAMAL BETHEA

who are named as defendants herein, and other persons whose identities are known to the Grand Jurors, who are named as coconspirators but not as defendants herein, between on or about February 12, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crimes of attempted murder, aggravated assault, and possession of a weapon

for an unlawful purpose, did agree together that:

- A. One or more of them would engage in conduct which would constitute the aforesaid crimes, or
- B. One of more them would aid in the planning, solicitation, or commission of said crimes, that is:
- 1. Purposely did attempt to cause the death of Shaiquan Hearns, contrary to the provisions for N.J.S.A. 2C:11-3a(1) and N.J.S.A. 2C:5-1.
- 2. Purposely did attempt to cause the death of Dion Battle, contrary to the provisions for N.J.S.A. 2C:11-3a(1) and N.J.S.A. 2C:5-1.
- 3. Purposely did attempt to cause serious bodily injury to Shaiquan Hearns and Dion Battle, while committing said crime Isiah Greene used a firearm, that is, a 40 S&W caliber Glock semiautomatic pistol, serial number WPN837, contrary to the provisions of N.J.S.A. 2C:12-1b(1).
- 4. Knowingly did possess a certain weapon, that is, a 40 S&W caliber Glock semiautomatic pistol, serial number WPN837, with the purpose to use it unlawfully against the person or property of another, contrary to the provisions of N.J.S.A. 2C:39-4a(1).

All in violation of $\underline{\text{N.J.S.A.}}$ 2C:5-2, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Attempted Murder - First Degree)

ISIAH GREENE

and

JAMAL BETHEA

on or about February 12, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, purposely did attempt to cause the death of Shaiquan Hearns, contrary to the provisions for N.J.S.A. 2C:11-3a(1), N.J.S.A. 2C:5-1, N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Attempted Murder - First Degree)

ISIAH GREENE

and

JAMAL BETHEA

on or about February 12, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, purposely did attempt to cause the death of Dion Battle, contrary to the provisions for N.J.S.A. 2C:11-3a(1), N.J.S.A. 2C:5-1, N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Aggravated Assault - Second Degree)

ISIAH GREENE

and

JAMAL BETHEA

on or about February 12, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, purposely did attempt to cause serious bodily injury to Shaiquan Hearns and Dion Battle, while committing said crime Isiah Greene used a firearm, that is, a 40 S&W caliber Glock semiautomatic pistol, serial number WPN837, contrary to the provisions of N.J.S.A. 2C:12-1b(1), N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Possession of a Weapon for an Unlawful Purpose - Second Degree)

ISIAH GREENE

and

JAMAL BETHEA

on or about February 12, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, did possess a certain weapon, that is, a 40 S&W caliber Glock semiautomatic pistol, serial number WPN837, with the purpose to use it unlawfully against the person or property of another, contrary to the provisions of N.J.S.A. 2C:39-4a(1), N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Unlawful Possession of a Weapon - Second Degree)

ISIAH GREENE

on or about February 12, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a 40 S&W caliber Glock semiautomatic pistol, serial number WPN837, without first having obtained a permit to carry same as provided in $\underline{N.J.S.A.}$ 2C:58-4, contrary to the provisions of $\underline{N.J.S.A.}$ 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Unlawful Possession of a Large Capacity Ammunition Magazine - Fourth Degree)

ISIAH GREENE

on or about February 12, 2020, at the City of Trenton, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine, contrary to the provisions of N.J.S.A. 2C:39-3j, and against the peace of this State, the government and dignity of the same.

COUNT EIGHT

(Hindering Apprehension or Prosecution of Self - Third Degree)

ISTAH GREENE

on or about February 12, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, with the purpose to hinder his own apprehension, prosecution, conviction, or punishment did suppress, by way of concealment or destruction, any evidence of the crime or tamper with a document or other source of information, regardless of its admissibility in evidence, which might aid in his discovery or apprehension or in the lodging of a charge against him; contrary to the provisions of N.J.S.A. 2C:29-3b(1) and against the peace of this State, government and dignity of the same.

COUNT NINE

(Hindering Apprehension or Prosecution of Another Person - Third Degree)

JAMAL BETHEA

between on or about February 12, 2020, and on or about February 14, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, with the purpose to hinder the apprehension, prosecution, conviction, or punishment of another person, that is, Isiah Greene, did give false information to a law enforcement officer, contrary to the provisions of N.J.S.A. 2C:29-3a(7) and against the peace of this State, government and dignity of the same.

COUNT TEN

(Unlawful Possession of a Weapon - First Degree)

ISIAH GREENE

on or about February 12, 2020, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, having been convicted of the crime(s) of Second Degree Aggravated Assault in Mercer County on Indictment 13-08-00989-I and/or Second Degree Recklessly Causes Death of Another in Mercer County on Indictment 14-04-00510-I, knowingly did possess a certain weapon, that is, a 40 S&W caliber Glock semiautomatic pistol, serial number WPN837, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, N.J.S.A. 2C:39-5j, and against the peace of this State, the government and dignity of the same.

COUNT ELEVEN

(Certain Persons Not to Have Weapons - Second Degree)

TSTAH GREENE

on or about February 12, 2020, at the City of Trenton, in the

County of Mercer, elsewhere, and within the jurisdiction of this

Court, having been convicted of the crime(s) of Second Degree

Aggravated Assault in Mercer County on Indictment 13-08-00989-I,

and/or Second Degree Recklessly Causes Death of Another in Mercer

County on Indictment 14-04-00510-I, and/or Second Degree Unlawful

Possession of a Weapon in Mercer County on Indictment 14-04-00510-

I, did purchase, own, possess or control the following firearm: a

40 S&W caliber Glock semiautomatic pistol, serial number WPN837,

contrary to the provisions of N.J.S.A. 2C:39-7b, and against the
