(Racketeering - First Degree)

and other persons whose identities are known and unknown to the Grand Jurors, who are named as co-conspirators and members of the enterprise, but not as defendants herein, at the times and places herein specified, did commit the crime of Racketeering, that is, the defendants and other persons employed by or associated with the enterprise engaged in the activities of which affected trade or commerce, purposely or knowingly did conduct or participate

directly or indirectly, or did conspire in the conduct of the enterprise's affairs through a pattern of racketeering activity, a crime of the first degree, in violation of <u>N.J.S.A.</u> 2C:41-2c and <u>N.J.S.A.</u> 2C:41-2d, all as hereinafter described.

# THE RELEVANT TIMES AND PLACES

The predicate criminal activity occurred between on or about April 18, 2018, and on or about July 7, 2019, at the Town of Harrison, at the Town of Secaucus, both in the County of Hudson, at the Town of Irvington, at the City of Newark, at the City of East Orange, all in the County of Essex, in the State of New Jersey, elsewhere, and within the jurisdiction of this Court.

#### THE ENTERPRISE

TIMOTHY GUEST, CARLOS RIVERA, WILLIAM WOODLEY, ALICIA BENTON, HANEEFA ROME, BARRY JAMES, GEORGE ENCARNACION, JONATHAN PEREZ-PAYANO, STEFFANY CASTILLO-CANDALARI, NELFY ULERIO, LEE HUDSON, and other persons whose identities are known and unknown to the Grand Jurors, who are named as co-conspirators and members of the enterprise, but not as defendants herein, did constitute an enterprise within the meaning of <u>N.J.S.A.</u> 2C:41-1c, that is, a group of individuals associated in fact, for the purposes set forth below.

#### THE PURPOSES OF THE ENTERPRISE

It was a part of the conspiracy that the purposes of the enterprise

would include the following:

- A. Obtaining money and property for members and associates of the enterprise through violations of the laws of the State of New Jersey, including the commission of the crimes of leader of a narcotics trafficking network; maintaining a controlled dangerous substance production facility; possession with intent to distribute a controlled dangerous substance; and money laundering;
- B. Accomplishing the goals of the enterprise through the collection of proceeds generated through the commission of various crimes from members of the enterprise, said proceeds to be utilized for the advancement and benefit of the enterprise and/or its leaders;
- C. To conceal from law enforcement authorities the existence of the enterprise, the means and locations from which it conducts its affairs, including but not limited to using wireless telephones, using associates to lease and/or buy vehicles to conceal the drivers of the vehicles, using a variety of locations, residences or motor vehicles for storage or delivery of controlled dangerous substances, which members and associates of the enterprise bought and sold.

# THE PATTERN OF RACKETEERING ACTIVITY

The pattern of racketeering activity, as defined in <u>N.J.S.A.</u> 2C:41-1d, consisted of at least two incidents of racketeering conduct by the enterprise during the relevant time, including Leader of a Narcotics Trafficking Network, (<u>N.J.S.A.</u> 2C:35-3); Maintaining a Controlled Dangerous Substance Production Facility (<u>N.J.S.A.</u> 2C:35-4); Possession with Intent to Distribute Controlled Dangerous Substances (<u>N.J.S.A.</u> 2C:35-5); Money Laundering (<u>N.J.S.A.</u> 2C:21-25); and Conspiracy to commit these crimes, as described herein and in Counts Two, Three, Five, Ten, Eleven, Twelve, Thirteen, Sixteen, Seventeen, Eighteen, Twenty-Five, Twenty-Six, Twenty-Seven, Twenty-Eight, Twenty-Nine, Thirty, Thirty-One, Thirty-Two, Thirty-Three, Thirty-Six, Thirty-Seven, Thirty-Eight, Forty-Two, Forty-Three, and Forty-Four of this Indictment.

#### TIMOTHY GUEST

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy, Leader of a Narcotics Trafficking Network; Maintaining a Controlled Dangerous Substance Production Facility; Possession with Intent to Distribute a Controlled Dangerous Substance; and Money Laundering; which racketeering conduct is the subject of Counts Two, Three, Five, Ten, Eleven, Twelve, Thirteen, Seventeen, Eighteen, Twenty-Five, Twenty-Six, Twenty-Seven, Twenty-Eight, Twenty-Nine, Thirty,

Thirty-One, and Thirty-Two of this Indictment.

#### CARLOS RIVERA

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Maintaining a Controlled Dangerous Substance Production Facility; and Possession with Intent to Distribute a Controlled Dangerous Substance; which racketeering conduct is the subject of Counts Two, Five, Ten, and Eleven of this Indictment.

# WILLIAM WOODLEY

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Maintaining a Controlled Dangerous Substance Production Facility; Possession with Intent to Distribute a Controlled Dangerous Substance; and Money Laundering which racketeering conduct is the subject of Counts Two, Five, Ten, Eleven, and Seventeen of this Indictment.

#### ALICIA BENTON

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; which racketeering conduct is the subject of Count Two and Count Five of this Indictment.

#### HANEEFA ROME

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Maintaining a Controlled Dangerous Substance Production Facility; Possession with Intent to

Distribute a Controlled Dangerous Substance; and Money Laundering which racketeering conduct is the subject of Counts Two, Eighteen, Twenty-Five, Twenty-Six, Twenty-Seven, Twenty-Eight, Twenty-Nine, Thirty, Thirty-One, and Thirty-Two of this Indictment.

#### BARRY JAMES

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Maintaining a Controlled Dangerous Substance Production Facility; Possession with Intent to Distribute a Controlled Dangerous Substance; and Money Laundering; which racketeering conduct is the subject of Counts Two, Eighteen, Twenty-Seven, Twenty-Eight, Twenty-Nine, Thirty, Thirty-One, and Thirty-Two of this Indictment.

#### GEORGE ENCARNACION

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Maintaining a Controlled Dangerous Substance Production Facility; Possession with Intent to Distribute a Controlled Dangerous Substance; and Money Laundering; which racketeering conduct is the subject of Counts Two, Thirty-Three, Thirty-Six, Thirty-Seven, Thirty-Eight, Forty-Two, and Forty-Three of this Indictment.

#### JONATHAN PEREZ-PAYANO

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Maintaining a Controlled

Dangerous Substance Production Facility; Possession with Intent to Distribute a Controlled Dangerous Substance; and Money Laundering; which racketeering conduct is the subject of Counts Two, Thirty-Three, Thirty-Six, Thirty-Seven, Thirty-Eight, and Forty-Four of this Indictment.

# STEFFANY CASTILLO-CANDALARI

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; which racketeering conduct is the subject of Counts Two and Forty-Four of this Indictment.

# LEE HUDSON

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; which racketeering conduct is the subject of Count Two of this Indictment.

All in violation of <u>N.J.S.A.</u> 2C:41-2c and <u>N.J.S.A.</u> 2C:41-2d, and against the peace of this State, the government and dignity of the same.

1. Knowingly or purposely distribute a controlled dangerous substance, that is, heroin, in a quantity of five ounces or more, including any adulterants or dilutants, contrary to the provisions of <u>N.J.S.A</u>. 2C:35-5a(1) and N.J.S.A. 2C:35-5b(1);

2. Knowingly or purposely distribute a controlled dangerous substance, that is, fentanyl, a schedule II narcotic drug, in a quantity of one ounce or more, including any adulterants or dilutants, contrary to the provisions of <u>N.J.S.A</u>. 2C:35-5a(1) and <u>N.J.S.A</u>. 2C:35-5b(4); and

3. Knowingly maintain or operate or knowingly participate in the maintenance or operations of a premise, place, or facility used for manufacturing

controlled dangerous substances, that is, heroin and/or fentanyl, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-4.

All in violation of <u>N.J.S.A.</u> 2C:5-2, and against the peace of this State, the government and dignity of the same.

on or about March 14, 2019, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, while operating a motor vehicle on any street or highway in this State, knowingly fled or attempted to elude any police or law enforcement officer after having received a signal from such officer to bring the vehicle to a full stop, and the flight or attempt to elude created a risk of death or injury to any person, contrary to the provisions of <u>N.J.S.A.</u> 2C:29-2b, and against the peace of this State, the government and dignity of the same.

on or about March 14, 2019, at the Town of Harrison, in the County of Hudson, elsewhere, and within the jurisdiction of this Court, knowingly did transport or possess property known, or which a reasonable person would believe to be derived from criminal activity, that is, approximately \$904 in U.S. currency, contrary to the provisions of <u>N.J.S.A.</u> 2C:21-25a, and against the peace of this State, the government and dignity of the same.

#### COUNT SEVENTEEN

(Money Laundering - First Degree)
