Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On September 22, 2021, during an audio and video recorded interview, the victim, who is an inmate, stated that on September 16, 2021 the defendant, Tyrell Harris-McLaughlin, who is a Corrections Officer at the Edna Mahan Correctional Facility for Women, penetrated her with his penis and ejaculated inside of her vagina. Afterward, the victim collected the semen from her body. An evidence collection kit was performed on the victim at Hunterdon Medical Center, and that kit along with the alleged semen collected by the victim was transported to the NJSP Laboratory for analysis. An initial forensic analysis was presumptive for the presence of semen on the swabs collected at the hospital and detected spermatozoa in the alleged semen provided by the victim. The NJSP Laboratory was also provided with control DNA sample from Harris-McLaughlin by way of a buccal swab. The buccal swab was compared to the evidence kit and alleged semen, and it was determined by the New Jersey State Police Laboratory that Harris-McLaughlin was the contributor of the DNA that was identified in the semen provided by the victim. Officer Tyrell Harris-McLaughlin is a public servant assigned to the Edna Mahan Correctional Facility for Women, where he has supervisory or disciplinary power over the victim. All inmates housed at the Facility, including the victim, are protected by the Prison Rape Elimination Act, 34 U.S.C.S. § 30301 et seq.
