The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Possession of a Controlled Dangerous Substance - Third Degree)

ISIAH FIELDS

on or about October 13, 2020, at the City of Atlantic City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, did knowingly or purposefully possess a controlled dangerous substance, that is, cocaine, a Schedule II controlled dangerous substance, contrary to the provisions of N.J.S.A. 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Possession with Intent to Distribute a
Controlled Dangerous Substance - Third Degree)

ISIAH FILEDS

on or about October 13, 2020, at the City of Atlantic City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, did knowingly or purposely possess with intent to distribute a controlled dangerous substance, that is, cocaine, contrary to the provisions of N.J.S.A. 2C:35-5, N.J.S.A. 2C:35-5b(3), and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Controlled Dangerous Substances Near or
On School Property - Third Degree)

ISIAH FIELDS

on or about October 13, 2020, at the City of Atlantic City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, did knowingly or purposefully possess with intent to distribute a controlled dangerous substance, that is, cocaine, in violation of N.J.S.A. 2C:35-5a, while within 1000 feet of the Our Lady Star of the Sea School, an elementary school, contrary to the provisions of N.J.S.A. 2C:35-7a, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Unlawful Possession of a Weapon - Second Degree)

ISIAH FILEDS

on or about October 13, 2020, at the City of Atlantic City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a Taurus Millennium G2 PT111 9MM handgun, Serial Number TKS47300, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Possession of a Weapon During the
Commission of Certain Crimes - Second Degree)

ISIAH FIELDS

on or about October 13, 2020, at the City of Atlantic City, in
the County of Atlantic, elsewhere, and within the jurisdiction
of this Court, knowingly did possess a certain weapon, that is,
a Taurus Millennium G2 PT111 9MM handgun, Serial Number
TKS47300, while in the course of committing or attempting to
commit, a violation of N.J.S.A. 2C:35-5a(1), contrary to the
provisions of N.J.S.A. 2C:39-4.1a, and against the peace of this
State, the government and dignity of the same.

COUNT SIX

(Eluding - Second Degree)

ISIAH FIELDS

on or about October 13, 2020, at the City of Atlantic City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, while operating a motor vehicle on a street or highway of this State, knowingly did flee or attempt to elude a police officer after having received a signal from the officer to stop, and while doing so did create a serious risk of death or injury to any person, contrary to the provisions of N.J.S.A. 2C:29-2b, and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Resisting Arrest - Fourth Degree)

ISIAH FIELDS

on or about October 13, 2020, at the City of Atlantic City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, purposely did prevent law enforcement officers of the Atlantic City Police Department from effecting a lawful arrest by fleeing on foot, contrary to the provisions of N.J.S.A. 2C:29-2a, and against the peace of this State, the government and dignity of the same.

COUNT EIGHT

(Obstructing Administration of Law or
Other Government Function - Fourth Degree)

ISIAH FIELDS

on or about October 13, 2020, at the City of Atlantic City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, purposely did prevent a public servant from lawfully performing an official function by means of flight, that is, fleeing a lawful arrest, thereby obstructing the detection or investigation of a crime, contrary to the provisions of N.J.S.A. 2C:29-1b, and against the peace of this State, the government and dignity of the same.

COUNT NINE

(Receiving Stolen Property - Third Degree)

ISIAH FIELDS

on or about October 13, 2020, at the City of Atlantic City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, did commit theft by knowingly receiving or bringing into this State movable property of Ralph Goff, that is a 2009 black Lexus sedan, Delaware registration 247045, knowing the same to be stolen or believing that it had probably been stolen, contrary to the provisions of N.J.S.A. 2C:20-7, and against the peace of this State, the government and dignity of the same.

COUNT TEN

(Certain Persons Not to Have Weapons - Second Degree)

ISIAH FIELDS

on or about October 13, 2020, at the City of Atlantic City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, having been convicted of the crime of Possession with Intent to Distribute CDS within 1,000 feet of School Property in Atlantic County, on Indictment number ATL-17-001784-001, and/or Possession with Intent to Distribute CDS within 1,000 feet of School Property in Atlantic County, on Indictment number ATL-18-001298-001, did own, possess, or control the following firearm: a Taurus Millennium G2 PT111 9MM handgun, serial number TKS47300, contrary to the provisions of N.J.S.A. 2C:39-7, and against the peace of this State, the government and dignity of the same.
