## COUNT ONE

(Conspiracy - Second Degree)

who are named as defendants herein, and other persons whose identities are known and unknown to the Grand Jurors, who are named as co-conspirators but not as defendants herein, between on or about September 25, 2020, and on or about November 19, 2020, at the City of Trenton, in the County of Mercer, in the State of South Carolina, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crimes of Transporting Weapons into the State for Unlawful Sale or Transfer, Unlawful Disposition of Firearms, Unlawful Disposition of Large Capacity Ammunition Magazines, did agree together, that:

- 1. One or more of them would engage in conduct which would constitute the aforesaid crimes, or
- 2. One or more of them would aid in the planning, solicitation or commission of said crimes, that is:
