The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Conspiracy - Second Degree)

EDUARDO T. LAZO

JUAN E. FERNANDEZ

and

ERICKNELL RIVERA-MERCADO

between on or about May 26, 2021, and on or about August 16, 2021, at the City of Camden, in the County of Camden, in the Commonwealth of Pennsylvania, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crimes of Transporting Weapons into the State for Unlawful

Sale or Transfer; Purchasing Firearm Parts to Manufacture a Firearm without a Serial Number; Manufacture, Transport, Disposition of an Assault Firearm; Transporting Manufactured Firearms without a Serial Number; Manufacture, Transport, Disposition of a Weapon; and Manufacture, Transport, Disposition of Large Capacity Ammunition Magazines, did agree together, and with a person whose identity is unknown to the Grand Jurors, who at all times relevant to this indictment was an agent of the New Jersey State Police, that:

- 1. One or more of them would engage in conduct which would constitute the aforesaid crime, or
- 2. One or more of them would aid in the planning, solicitation, or commission of said crime, that is:
- A. Knowingly or purposely transport, ship, or otherwise bring into this State any firearm for the purpose of unlawfully selling, transferring, giving, assigning, or disposing of that firearm to another individual, contrary to the provisions of N.J.S.A. 2C:39-9i;
- B. Purchase or otherwise obtain separately or as part of a kit a firearm frame or firearm receiver which is not imprinted with a serial number registered with a federally licensed manufacturer or any combination of parts from which a firearm without a serial number may be readily manufactured or otherwise assembled, but which does not have the capacity to function as a

firearm unless manufactured or otherwise assembled, with the purpose to manufacture or otherwise assemble a firearm without being registered of licensed to do so as provided in Chapter 58, contrary to the provisions of N.J.S.A. 2C:39-9k;

- C. Knowingly transport, ship, sell, or dispose of an assault firearm, without being licensed or registered to do so pursuant to N.J.S.A. 2C:58-1 et. seq., contrary to the provisions of N.J.S.A. 2C:39-9g;
- D. Knowingly transport, ship, sell, or dispose of a firearm without being licensed or registered to do so as provided in Chapter 58, contrary to the provisions of N.J.S.A. 2C:39-9d;
- E. Transport, ship, sell, or dispose of a firearm manufactured or otherwise assembled using a firearm frame or firearm receiver which is not imprinted with a serial number registered with a federally licensed manufacturer, including but not limited to a firearm manufactured or otherwise assembled from parts purchased or otherwise obtained as defined in N.J.S.A. 2C:39-9k, contrary to the provisions of N.J.S.A. 2C:39-9n; and
- F. Knowingly transport, ship, sell, or dispose of a large capacity ammunition magazine, contrary to the provisions of N.J.S.A. 2C:39-9h.

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.

(Transporting Weapons into the State for Unlawful Sale or Transfer - Second Degree)

COUNT THREE

(Purchasing Firearm Parts to Manufacture a Firearm Without a Serial Number - Third Degree)

between on or about May 26, 2021, and on or about August 11, 2021, at the City of Camden, in the County of Camden, in the Commonwealth of Pennsylvania, elsewhere, and within the jurisdiction of this Court, did, with the purpose to manufacture or otherwise assemble a firearm, and without being registered or licensed to manufacture a firearm pursuant to Chapter 58, purchase or otherwise obtain separately or as part of a kit, a firearm frame, or firearm receiver which was not imprinted with a serial number registered with a federally licensed manufacturer or any combination of parts from which a firearm without a serial number may be readily manufactured or otherwise assembled, but which does not have the capacity to function as a firearm unless manufactured or otherwise assembled, contrary to the provisions of N.J.S.A. 2C:39-9k, N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.
