# COUNT ONE

(Conspiracy - Second Degree)

NADIR ROBERTS

TIYANN BUNN

NATHANIAL JACKSON

QUADIR ROBERTS

AND

NAZIR HEYWARD

who are named as defendants herein, and other persons whose identities are unknown to the Grand Jurors, who are named as coconspirators but not as defendants herein, between on or about February 1, 2020, and on or about August 17, 2020, at the city of Irvington, in the County of Essex, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crime of Maintaining or Operating a Controlled Dangerous Substance Production Facility and/or Distribution of a Controlled Dangerous Substance, did agree that:

- A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crimes, or
- B. One or more of them knowingly would aid in the planning, solicitation, or commission of said crimes, that is:
  - 1. Knowingly did maintain or operate or knowingly did participate in the maintenance or operation of a premise, place or facility used for manufacturing a controlled dangerous substance, that is, heroin and/or cocaine, contrary to the provisions of N.J.S.A. 2C:35-4;
  - 2. Knowingly or purposely distribute a controlled dangerous substance, that is, heroin and/or cocaine, in a quantity of five ounces or more including any adulterants or dilutants, contrary to the provisions of N.J.S.A. 2C:35-5a(1), N.J.S.A. 2C:35-5b(1),

3. Knowingly or purposely distribute a controlled dangerous substance, that is, marijuana, in a quantity of one ounce or more including any adulterants or dilutants, contrary to the provisions of  $\underline{\text{N.J.S.A.}}$  2C:35-5a(1),  $\underline{\text{N.J.S.A.}}$  2C:35-5b(11).

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.

# COUNT TWO

(Promoting Organized Street Crime - First Degree)

NADIR ROBERTS

between on or about February 1, 2020, and on or about August 17, 2020, at the city of Irvington, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly did conspire with others as an organizer, supervisor, financier or manager to commit one or more of the crimes enumerated in N.J.S.A. 2C:33-30, specifically, Distribution of a Controlled Dangerous Substance, and/or Possession with Intent to Distribute a Controlled Dangerous Substance, in violation of N.J.S.A. 2C:35-5a(1) and b, and/or, Maintaining or Operating a Controlled Dangerous Substance Production Facility, in violation of N.J.S.A. 2C:35-4, contrary to the provisions of N.J.S.A. 2C:33-30, and against the peace of this State, the government and dignity of the same.

(Possession of a Firearm During the Commission of Certain Crimes - Second Degree)

(Possession of a Large Capacity Ammunition Magazine - Fourth Degree)

on or about August 17, 2020, at the city of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine, contrary to the provisions of N.J.S.A. 2C:39-3j and N.J.S.A. 2C:2-6, and against the peace of this State, the government and the dignity of the same.

# COUNT TWENTY-TWO

(Money Laundering - Third Degree)

### NADIR ROBERTS

AND

## TIYANN BUNN

on or about August 17, 2020, at the city of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly did transport or possess property known, or which a reasonable person would believe to be derived from criminal activity, that is, approximately \$8,952 in U.S. currency, contrary to the provisions of N.J.S.A. 2C:21-25(a) and N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

## COUNT TWENTY-THREE

(Endangering the Welfare of a Child - Second Degree)

#### TIYANN BUNN

between on or about February 1, 2020, and on or about August 17, 2020, at the city of Newark, at the city of Irvington, in the County of Essex, elsewhere, and within the jurisdiction of this Court, having a legal duty for the care of, or having assumed responsibility for the care of N.B., born November 1, 2018, knowingly did cause harm to N.B., making N.B. an abused or neglected child as defined in R.S. 9:6-1, R.S. 9:6-3 and P.L. 1974, c. 119, s.1, (C. 9:6-8:21), contrary to the provisions of N.J.S.A. 2C:24-4a, and against the peace of this State, the government and dignity of the same.

## COUNT TWENTY-FOUR

(Hindering Apprehension - Third Degree)

#### DEANDRE MARTINEZ

between on or about August 25, 2020, and on or about October 9, 2020, at the city of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, with purpose to hinder the apprehension, prosecution, conviction or punishment of another person, that is, Nadir Roberts, Tiyann Bunn and/or Nathanial Jackson, did give false information to a law enforcement officer, contrary to the provisions of N.J.S.A. 2C:29-3a(7), and against the peace of this State, the government and dignity of the same.

(Possession of a Weapon by a Convicted Person - Second Degree)

on or about August 17, 2020, at the city of Newark, at the City of Irvington, in the County of Essex, elsewhere, and within the jurisdiction of this Court, having been convicted of the crime of Distribution and/or Possession with Intent to Distribute a Controlled Dangerous Substance on Essex County Indictment 06-04-01264-I, and/or the crime of Prohibited Weapons/Devices on Essex County Indictment 06-04-01264-I and/or the crime of Possession of Certain Bullets on Essex County Indictment 06-04-01264-I and/or the crime of Distribution and/or Possession with Intent to Distribute a Controlled Dangerous Substance on Essex County Indictment 06-05-01535-I and/or the crime of Distribution and/or Possession with Intent to Distribute a Controlled Dangerous Substance on Essex County Indictment 06-05-01535-I and/or the crime of Distribution and/or Possession with Intent to Distribute a Controlled Dangerous Substance within 1,000 feet of School Property on Essex County Indictment 07-06-02251-I, did purchase, own, possess or control a firearm, that is, a black Glock 19 bearing serial number AXG818 and/or a black and silver Smith and Wesson 38 caliber revolver, bearing serial number CEN2685 and/or a black Beretta PX4 Storm bearing serial number PX0927U, contrary to the provisions of N.J.S.A. 2C:39-7b, and

against the peace of this State, the government and dignity of the same.
