INVESTIGATION REVEALS THAT MARIKA SPROW IS EMPLOYED BY THE NEW JERSEY DEPARTMENT OF CORRECTIONS AS A SENIOR CORRECTIONAL POLICE OFFICER. ON OR ABOUT JANUARY 11 AND JANUARY 12, 2021, BETWEEN 11:40 P.M., AND 1:15 A.M., SPROW AND OTHER NEW JERSEY DEPARTMENT OF CORRECTIONS (DOC) OFFICERS AND EMPLOYEES WERE ASSIGNED TO THE EDNA MAHAN CORRECTIONAL FACILITY FOR WOMEN (EMCFW) IN CLINTON, NEW JERSEY AND CONDUCTED CELL EXTRACTIONS OF VARIOUS INMATES LOCATED IN THE RHU (RESTORATIVE HOUSING UNIT) COMPLEX, WHERE 21 INMATES WERE HOUSED.
