INDICTMENT

The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Unlawful Possession of an Assault Firearm - Second Degree)

HASSAN WILSON

VENESHA PINKNEY

and

DEWAYNE PINKNEY

on or about February 24, 2021, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did have in their possession an assault firearm, that is, a 9mm Luger caliber Intratec model Tec-DC9 semi-automatic

pistol, with a defaced serial number (given identification number NJ210401), contrary to the provisions of N.J.S.A. 2C:39-5f, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Possession of a Defaced Firearm - Fourth Degree)

HASSAN WILSON

on or about February 24, 2021, at the City of Trenton, in the County of Mercer, elsewhere and within the jurisdiction of this Court, knowingly did possess a prohibited weapon, that is, a 9mm Luger caliber Intratec model Tec-DC9 semi-automatic pistol with a defaced serial number, (given identification number NJ210401) contrary to the provisions of N.J.S.A. 2C:39-3d, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Unlawful Possession of a Large Capacity
Ammunition Magazine - Fourth Degree)

HASSAN WILSON

VENESHA PINKNEY

and

DEWAYNE PINKNEY

on or about February 24, 2021, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine, contrary to the provisions of N.J.S.A. 2C:39-3j, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Unlawful Possession of a Weapon - First Degree)

DEWAYNE PINKNEY

on or about February 24, 2021, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, having been previously convicted of the crime of Second Degree Burglary in Mercer County, on Indictment number MER961201379I, knowingly did possess a certain weapon, that is, a 9mm Luger caliber Intratec model Tec DC9 semi-automatic pistol, identification number NJ210401, contrary to the provisions of N.J.S.A. 2C:39-5f, N.J.S.A. 2C:39-5j, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Certain Persons Not to Have Weapons - Second Degree)

DEWAYNE PINKNEY

on or about February 24, 2021, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, having been convicted of the crime of Third Degree Possession with Intent to Distribute a Controlled Dangerous Substance/Distribution of a Controlled Dangerous Substance within 1000 feet of School Property in Mercer County, on Indictment number I135-89; and/or Third Degree Possession with Intent to Distribute a Controlled Dangerous Substance/Distribution of a Controlled Dangerous Substance within 1000 feet of School Property in Mercer County, on Accusation number A432-89; and/or Second Degree Unlawful Possession of a Weapon in Mercer County on Indictment number MER950200221I; and/or Second Degree Burglary in Mercer County, on Indictment number MER961201379I; and/or Fourth Degree Aggravated Assault with a Firearm in Mercer County, on Indictment number MER050500424I, did purchase, own, possess, or control the following firearm: a 9mm Luger caliber Intratec model Tec DC9 semi-automatic pistol, identification number NJ210401, contrary to the

provisions of N.J.S.A. 2C:39-7b, and against the peace of this State, the government and dignity of the same.
