The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Transporting Weapons into the State for Unlawful Sale or Transfer - Second Degree)

BARRETT GRIFFIN

between on or about February 5, 2022, and on or about February 7, 2022, at the Township of Mount Laurel, in the County of Burlington, in the State of Georgia, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did transport, ship, or otherwise bring into this State a firearm for the purpose of unlawfully selling, transferring, giving, assigning, or disposing of that firearm to another individual, contrary to <u>N.J.S.A.</u> 2C:39-9i, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Unlawful Possession of a Weapon - Second Degree) BARRETT GRIFFIN

on or about February 7, 2022, at the Township of Mount Laurel, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon(s), that is, a 10mm Glock 20 semiautomatic pistol, serial number BPMT560; and/or a 9mm Ruger P94DC semiautomatic pistol, serial number 30848951; and/or a .45 caliber American Classic Commander semiautomatic pistol, serial number A06583; and/or a 9mm Beretta M9, semiautomatic pistol, serial number 171898; and/or a 9mm Glock 17 semiautomatic pistol, serial number BMS851, without first having obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Unlawful Possession of an Assault Firearm - Second Degree) BARRETT GRIFFIN

on or about February 7, 2022, at the Township of Mount Laurel, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, knowingly did possess an assault firearm, that is, a 9mm Grand Power LTD Stribog SP9A1, semiautomatic pistol, serial number GSA3281, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-5f, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Unlawful Possession of Large Capacity Ammunition Magazines - Fourth Degree)

BARRETT GRIFFIN

on or about February 7, 2022, at the Township of Mount Laurel, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, knowingly did possess four large capacity ammunition magazines, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-3j, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Unlawful Possession of a Weapon - First Degree)

BARRETT GRIFFIN

on or about February 7, 2022, at the Township of Mount Laurel, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, having been convicted of the crime of Second Degree Aggravated Assault in Somerset County on Indictment Number SOM-07-07-00473I, knowingly did possess a certain weapon, that is a 10mm Glock 20 semiautomatic pistol, serial number BPMT560; and/or a 9mm Ruger P94DC semiautomatic pistol, serial number 30848951; and/or a .45 caliber American Classic Commander semiautomatic pistol, serial number A06583; and/or a 9mm Beretta M9, semiautomatic pistol, serial number 171898; and/or a 9mm Glock 17 semiautomatic pistol, serial number BMS851,without having first obtained a permit to carry same as provided in <u>N.J.S.A.</u> 2C:58-4, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-5b, <u>N.J.S.A.</u> 2C:39-5j, and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Unlawful Possession of an Assault Firearm - First Degree)

BARRETT GRIFFIN

on or about February 7, 2022, at the Township of Mount Laurel, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, having been convicted of the crime of Second Degree Aggravated Assault in Somerset County on Indictment Number SOM-07-07-00473I, knowingly did possess an assault firearm, that is, a 9mm Grand Power LTD Stribog SP9A1 semiautomatic pistol, serial number GSA3281, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-5f, <u>N.J.S.A.</u> 2C:39-5j, and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Certain Persons Not to Possess a Firearm - Second Degree)

BARRETT GRIFFIN

on or about February 7, 2022, at the Township of Mount Laurel, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, having been previously convicted of the crimes of Second Degree Aggravated Assault and Second Degree Possession of a Firearm for an Unlawful Purpose, in Somerset County on Indictment Number SOM-07-07-00473I, and/or Unlawful Possession of a Weapon in Middlesex County on Indictment Number MID-08-04-00519-I, did purchase, own, possess, or control the following firearm: a 10mm Glock 20 semiautomatic pistol, serial number BPMT560; and/or a 9mm Ruger P94DC semiautomatic pistol, serial number 30848951; and/or a .45 caliber American Classic Commander semiautomatic pistol, serial number A06583; and/or a 9mm Beretta M9, semiautomatic pistol, serial number 171898; and/or a 9mm Glock 17 semiautomatic pistol, serial number BMS85; and/or a 9mm Grand Power LTD Stribog SP9A1 semiautomatic pistol, serial number GSA3281, contrary to the provisions of N.J.S.A. 2C:39-7b, and against the peace of this

State, the government and dignity of the same.
