their oaths, present that:

COUNT ONE

(Conspiracy - Second Degree)

who are named as defendants herein, and other persons whose identities are known and unknown to the Grand Jurors, who are named as coconspirators but not as defendants herein, between on or about January 6, 2020, and on or about June 5, 2020, at the City of Paterson, in the County of Passaic, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crimes of Operation of a Facility for the Sale of Stolen Automobile Parts, Receiving Stolen Property, and Tampering with Public Records, did agree together that:

A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crimes, or

B. One or more of them knowingly would aid in the planning, solicitation or commission of said crimes, that is:

1. Knowingly maintain or operate any premises, place, or facility used for the remodeling, repainting, or separating of automobile parts for resale of any stolen automobile, contrary to the provisions of N.J.S.A. 2C:20-16a; and

2. Knowingly receive or bring into this State movable property of another knowing that it has been stolen, or believing that it is probably stolen, contrary to the provisions of N.J.S.A. 2C:20-7a.

3. Knowingly make, present, offer for filing, or use any record, document, or thing belonging to, or received or kept by, the government for information or record, or required by law to be kept by others for information of the government, knowing it to be false, contrary to the provisions of N.J.S.A. 2C:28-7a(2).

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.

(Receiving Stolen Property - Third Degree)

(False Statement to Motor Vehicle Commission - Third Degree)

on or about April 9, 2019, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, purposely or knowingly did make a misrepresentation or false statement in any title papers or other papers submitted to the Chief Administrator of the New Jersey Motor Vehicle Commission in connection therewith, contrary to the provisions of N.J.S.A. 2C:21-4.8b(1), and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Filing a False Motor Vehicle Title - Third Degree)

on or about April 9, 2019, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, purposely or knowingly did use title papers on or for a wrong motor vehicle, with intent to evade or violate the requirements of chapter 10 of Title 39 of the Revised Statutes, contrary to the provisions of N.J.S.A. 2C:21-4.8b(5), and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Tampering with Public Records - Third Degree)

COUNT EIGHT

(Filing a False Motor Vehicle Title - Third Degree)
