The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Kidnapping - First Degree)

JAMES PARILLO

Between on or about February 1, 2022 and on or about February 7, 2023, at the Township of Bass River, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, did unlawfully confine D.M. for a substantial period, with the purpose to facilitate commission of any crime or flight thereafter and/or to inflict bodily injury on or to terrorize D.M. or another, contrary to the provisions of <u>N.J.S.A.</u> 2C:13-1(b)(1) and (b)(2), and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Aggravated Sexual Assault - First Degree)

JAMES PARILLO

On diverse occasions, between on or about February 1, 2022 and on or about February 7, 2023, at the Township of Bass River, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, did knowingly commit an act and/or acts of sexual penetration, specifically intercourse, with D.M. during the commission or attempted commission of kidnapping and/or aggravated assault of D.M., contrary to the provisions of <u>N.J.S.A.</u> 2C:14-2a(3), and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Aggravated Sexual Assault - First Degree)

JAMES PARILLO

On diverse occasions, between on or about February 1, 2022 and on or about February 7, 2023, at the Township of Bass River, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, did knowingly commit an act and/or acts of sexual penetration, specifically fellatio, with D.M. during the commission or attempted commission of kidnapping and/or aggravated assault of D.M., contrary to the provisions of <u>N.J.S.A.</u> 2C:14-2a(3), and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Sexual Assault - Second Degree)

JAMES PARILLO

On diverse occasions, between on or about February 1, 2022 and on or about February 7, 2023, at the Township of Bass River, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, did knowingly commit an act and/or acts of sexual penetration, specifically fellatio, with D.M. and did use physical force and/or coercion but D.M. did not sustain severe personal injury, contrary to the provisions of <u>N.J.S.A.</u> 2C:14-2c(1), and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Sexual Assault - Second Degree)

JAMES PARILLO

On diverse occasions, between on or about February 1, 2022 and on or about February 7, 2023, at the Township of Bass River, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, did knowingly commit an act and/or acts of sexual penetration, specifically intercourse, with D.M. and did use physical force and/or coercion but D.M. did not sustain severe personal injury, contrary to the provisions of <u>N.J.S.A.</u> 2C:14-2c(1), and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Aggravated Assault - Third Degree)

JAMES PARILLO

On diverse occasions, between on or about February 1, 2022 and on or about February 7, 2023, at the Township of Bass River, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, did attempt to cause significant bodily injury to D.M. and/or did purposely or knowingly cause significant bodily injury to D.M., and/or under circumstances manifesting extreme indifference to the value of human life, did recklessly, cause significant bodily injury to D.M., a person who, with respect to the actor, meets the definition of a victim of domestic violence as defined by subsection d. of section 3 of P.L. 1991, c. 261 (2C:25-19), contrary to the provisions of <u>N.J.S.A.</u> 2C:12-1b(12), and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Aggravated Assault - Second Degree)

JAMES PARILLO

Between on or about February 1, 2022 and on or about February 7, 2023, at the Township of Bass River, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, did knowingly, and/or under circumstances manifesting extreme indifference to the value of human life, recklessly obstruct the breathing or blood circulation of D.M., a person who, with respect to the actor, meets the definition of a victim of domestic violence as defined in subsection d. of section 3 of P.L. 1991, c. 261 (2C:25-19), by applying pressure on the throat or neck or blocking the nose or mouth of such person, thereby causing or attempting to cause bodily injury, contrary to the provisions of N.J.S.A.2C:12-1b(13), and against the peace of this State, the government and dignity of the same.

COUNT EIGHT

(Criminal Restraint - Third Degree)

JAMES PARILLO

Between on or about February 1, 2022 and on or about February 7, 2023, at the Township of Bass River, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, did knowingly restrain D.M. unlawfully, in circumstances exposing D.M. to risk of serious bodily injury, contrary to the provisions of <u>N.J.S.A</u>.2C:13-2a, and against the peace of this State, the government and dignity of the same.

COUNT NINE

(Criminal Coercion - Third Degree)

JAMES PARILLO

On diverse occasions between on or about February 1, 2022 and on or about February 7, 2023, at the Township of Bass River, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, did, with purpose unlawfully to restrict another's freedom of action to engage or refrain from engaging in conduct, threaten to inflict bodily injury on anyone or commit any offense, contrary to the provisions of <u>N.J.S.A</u>.2C:13-5, and against the peace of this State, the government and dignity of the same.

COUNT TEN

(Theft by Extortion - Second Degree)

JAMES PARILLO

On diverse occasions between on or about February 1, 2022 and on or about February 7, 2023, at the Township of Bass River, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, did purposely and unlawfully obtain property of another by extortion, contrary to the provisions of $\underline{N.J.S.A.2C:20-5}$ and $\underline{N.J.S.A.2C:20-2b(1)}$ (b), and against the peace of this State, the government and dignity of the same.

COUNT ELEVEN

(Hindering - Third Degree)

JAMES PARILLO

On or about February 7, 2023, at the Township of Bass River, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, did with purpose to hinder his own detention, apprehension, investigation, prosecution, conviction of punishment for an offense, gave false information to a law enforcement officer, contrary to the provisions of <u>N.J.S.A</u>.2C:29-3b, and against the peace of this State, the government and dignity of the same.
