ADOPTIONS LAW AND PUBLIC SAFETY

13:35-6A.4 Standards for declaration of brain death

Declarations of brain death shall be made by a physician, meeting the requirements set forth in N.J.A.C. 13:35-6A.3, based upon the exercise of the physician's best medical judgment and in accordance with currently accepted medical standards that are based upon nationally recognized sources of practice guidelines, including, without limitation, guidelines adopted by the American Academy of Neurology.

13:35-6A.7 Pronouncement of death

The examining physician shall document the determination of brain death in the patient record and shall sign the chart. The actual pronouncement of death may thereafter be made by the examining physician or any plenary licensed physician acting upon the authorization of the examining physician.

Take notice that pursuant to N.J.S.A. 52:14B-5.1, the Boat Safety Course rules at N.J.A.C. 13:61 were scheduled to expire on November 23, 2017. N.J.S.A. 12:7-60 requires that the Superintendent of State Police establish a list of approved boat safety courses, offered by public or private persons or agencies for profit or otherwise, and taught by approved boat safety instructors. The rules at N.J.A.C. 13:61 outline the procedures for obtaining approval of a boat safety course for formal instruction in power vessel safety and handling, and the establishment of a list of approved boat safety courses. The Division of State Police has reviewed these rules and determined that the rules should be readopted, with technical changes, because they are necessary, reasonable, and proper for the purpose for which they were originally promulgated. The technical changes update the National Association of State Boating Law Administrators address in N.J.A.C. 13:61-1.4(a) and remove the effective date of the Internet course information in N.J.A.C. 13:61-1.4(d)3.

In accordance with N.J.S.A. 52:14B-5.1.c(1), timely filing of this notice extends the expiration date of the chapter seven years from the date of filing.

Full text of the technical changes follows (additions in boldface **thus**; deletions indicated in brackets [thus]):

SUBCHAPTER 1. BOAT SAFETY COURSE REQUIREMENTS

13:61-1.4 Course requirements; requirements for approval

(a) Course materials submitted for approval shall comply with the National Association of State Boating Law Administrators (NASBLA) boat safety course standards 1.1 through 8.2.14, and R1 through R4, as published in the [2010] 2016 version of the "National Boating Education Standards," incorporated herein by reference, as amended and supplemented, in effect at the time the course is submitted. The standards may be obtained from the National Association of State Boating Law Administrators, [1500 Leestown Rd, Ste 330.] 1648 McGrathiana Parkway, Lexington, KY 40511 or online at www.nasbla.org. Delivery of approved courses shall comply with the standards in effect at the time that the course is taught.

(b)-(c) (No change.)

(d) Except as provided in (d)3 below, an approved course shall be a minimum of eight hours in length. The eight hours shall consist of at

least six hours of in-person formal instruction by an approved boat safety instructor. A 10 minute, non-cumulative break within each hour of instruction is permitted. The remaining two hours shall consist of either in-person formal instruction or home study assigned by the instructor, which shall require the completion of written homework, and up to one hour for testing. All instruction required under (a) and (b) above shall be covered through in-person formal instruction and may be supplemented through written homework.

- 3. An Internet course that is submitted for approval is subject to all requirements of this chapter, except the requirement for in-person classroom instruction.
- i. The Internet course shall provide the equivalent of eight hours of instruction. The Internet course shall be constructed in a way that does not allow the student to skip any pages or sections, or complete the online portion of the course in less than five hours. Each section or page of an Internet course shall be displayed for an amount of time appropriate for the complexity and amount of content found in that section or page. The five hours shall not include the time required to complete the comprehensive review quizzes set forth in (d)3iii below or the in-person proctored test required by (e) below. The course shall be so constructed as to allow the student to stop and re-start, and return to complete the course at a later time, thus, not requiring that the course be completed without pause. Courses may include graphics, and when possible, include animation (video, etc) to demonstrate various concepts. [The provisions of this paragraph shall become operative as of March 1, 2011.]

Take notice that pursuant to N.J.S.A. 52:14B-5.1, the rules at N.J.A.C. 13:70 were scheduled to expire on December 7, 2017. In accordance with N.J.S.A. 5:5-30, the rules at N.J.A.C. 13:70 establish the rules regulating thoroughbred horse racing in New Jersey. The rules at N.J.A.C. 13:70 also establish general standards of practice within the industry.

The rules proposed for readoption have had an advantageous impact on the regulation and conduct of racing, industry participants, and racetrack permitholders. The chapter proposed for readoption contains 32 subchapters, described as follows:

Subchapter 1, General Rules, contains the chapter's rules of general applicability, including applicability of the rules, standards of behavior, and racetrack policing requirements.

Subchapter 2, Definitions, defines various terms used in Chapter 70, including the definition of racing terminology as relevant to the thoroughbred industry.

Subchapter 3, Racing Associations, sets forth various requirements placed upon permitted racing associations, including conditions and procedures for licensure, equipment and facility maintenance, prohibited activities on the grounds of a racetrack, insurance maintenance requirements, and admission age criteria.

Subchapter 4, Licensing, contains the procedures and fees for licensure.
