IN THE MATTER OF THE APPLICATION OF ACRA TURF CLUB, LLC, TO RENEW ITS OFF-TRACK WAGERING LICENSE, TO OPERATE AN OFF-TRACK WAGERING FACILITY IN *VINELAND CITY*, NEW JERSEY, FOR THE PERIOD JANUARY 1, 2014, THROUGH DECEMBER 31, 2014

WHEREAS, ACRA Turf Club, LLC (hereinafter "applicant"), holds an off-track wagering facility license, authorizing it to operate an off-track wagering facility in Vineland City, New Jersey, which license is scheduled to expire December 31, 2013;

WHEREAS, the applicant has filed an application with the New Jersey Racing Commission ("Racing Commission"), pursuant to <u>N.J.A.C.</u> 13:74-2.2, seeking the renewal of the said off-track wagering license issued to it, for the period encompassing calendar year 2014;

WHEREAS, the Racing Commission considered this matter at its public meeting on November 20, 2013;

WHEREAS, the Racing Commission did find at such time that the applicant continues to meet all legal requirements set forth in the "Off-Track and Account Wagering Act," that the applicant continues to meet all legal requirements set forth in the rules of the Racing Commission, inclusive of N.J.A.C. 13:74-2.2, and that the applicant is in substantial compliance with the conditions and terms imposed upon it, for it to hold an off-track wagering license to operate the said off-track wagering facility;





IT IS THEREFORE ORDERED THAT the license presently held by the applicant, to operate the said off-track wagering facility, shall be renewed for the period January 1, 2014, through December 31, 2014, subject to the conditions set forth in Schedule A and B as attached to this Order and incorporated herein;

IT IS FURTHER ORDERED THAT the determinations, as set forth in this Order, are subject to the review and approval of Acting Attorney General John J. Hoffman, pursuant to <u>N.J.A.C.</u> 13:74-2.2(h); and

IT IS FURTHER ORDERED THAT, subject to the review and approval of the Attorney General, the Racing Commission Executive Director shall cause a renewal license to issue to the applicant for its operation of an off-track wagering facility, consistent with the terms and conditions of this Order.

This Order memorializes the action taken by the Racing Commission at its public meeting of November 20, 2013.

SCHEDULE B - ADDITIONAL CONDITIONS APPLICABLE TO THE VINELAND CITY OFF-TRACK WAGERING FACILITY - 2014 CALENDER YEAR LICENSE RENEWAL

1B) The off-track wagering licensee may not engage in account wagering until the off-track wagering licensee applies to the Racing Commission, and receives approval from the Racing Commission, to include the facility in the account wagering initiative.
