**FINAL DETERMINATION AND ORDER
OF THE NEW JERSEY RACING COMMISSION**

**Consider the Request of Freehold Raceway Off-Track, LLC
for a Renewal License for Calendar Year 2015 for the Off-
Track Wagering Facility, "Favorites at Gloucester Township"**

WHEREAS, the Commission issued an initial off-track wagering license to "Favorites at Gloucester Township" on July 2, 2014 which was valid from July 1, 2014 to July 1, 2015;

WHEREAS, by letter dated October 6, 2014, Freehold Raceway Off-Track, LLC ("FROT") sought the renewal of the initial off-track wagering license issued for "Favorites at Gloucester Township" pursuant to N.J.A.C. 13:74-2.3(b) to extend the term of the initial off-track wagering license to December 31, 2015;

WHEREAS, the Commission considered FROT's request at its January 14, 2015 public meeting;

AND THE COMMISSION FINDING that the requirements for renewal set forth in N.J.A.C. 13:74-2.3 having been met:


IT IS THEREFORE ORDERED THAT the Initial Off-Track Wagering Facility License issued to "Favorites at Gloucester Township" shall be renewed for the term of July 2, 2015 through December 31, 2015 subject to the conditions set forth in the Commission's Final Determination and Order, dated October 28, 2013;



IT IS FURTHER ORDERED THAT pursuant to N.J.A.C. 13:74-2.3(j), this Final Determination and Order of the New Jersey Racing Commission shall be subject to the review and approval of the Attorney General.

THIS ORDER memorializes the action taken by the Commission at its public meeting on January 14, 2015.
