FINAL DETERMINATION AND ORDER

IN THE MATTER OF THE
APPROVAL OF THE EXTENSION OF
THE INITIAL OFF-TRACK WAGERING
LICENSE FOR THE FAVORITES AT
HILLSBOROUGH OFF-TRACK
WAGERING FACILITY TO
DECEMBER 31, 2016 PURSUANT
TO N.J.A.C. 13:74-2.3(B)

WHEREAS, the New Jersey Racing Commission approved the issuance of an initial off-track wagering license to the New Jersey Thoroughbred Horsemen’s Association (“THA”) for the Favorites at Hillsborough off-track wagering facility in a Final Determination and Order, dated September 21, 2015, subject to the conditions set forth therein;

WHEREAS, the Attorney General approved the issuance of the initial off-track wagering license for the Favorites at Hillsborough off-track wagering facility on October 6, 2015;

WHEREAS, on October 20, 2015, the Commission issued an initial off-track wagering license to the THA which was valid from October 22, 2015 to October 22, 2016;

WHEREAS, by letter dated September 2, 2016, John F. Heims, Esq. filed a letter with the Commission on behalf of the THA requesting that the initial off-track wagering license for Favorites at Hillsborough be extended from October 22, 2016 through December 31, 2016 pursuant to N.J.A.C. 13:74-2.3(b);



WHEREAS, the Commission considered the THA's request at its September 14, 2016 public meeting;

AND THE COMMISSION FINDING that the requirements for extension set forth in N.J.A.C. 13:74-2.3(b) have been met:


IT IS THEREFORE ORDERED that the initial off-track wagering license issued to the THA for the Favorites at Hillsborough off-track wagering facility shall be extended from October 22, 2016 to December 31, 2016 subject to the conditions set forth in its Final Determination and Order, dated September 21, 2015, in order to bring the Hillsborough off-track wagering facility into conformity with the calendar-year, license-renewal schedule followed by the off-track wagering facilities.

AND IT IS FURTHER ORDERED that this Final Determination and Order shall be subject to the review and approval of the Attorney General pursuant to N.J.A.C. 13:74-2.3(j).

THIS ORDER memorializes the action taken by the Commission at its September 14, 2016 public meeting.
