DIRECTIVE #11
Amended August 8, 1984

THE FOLLOWING GUIDELINES ARE HEREBY PROMULGATED TO AID COMMISSION PERSONNEL AND N.J. STATE POLICE PERSONNEL IN EVALUATING THE ELIGIBILITY FOR COMMISSION LICENSURE OF INDIVIDUALS HAVING CONVICTIONS FOR INDICTABLE OFFENSES.

1. APPLICANTS HAVING CRIMINAL CONVICTIONS WITHIN THE 10 YEAR PERIOD PRECEDING THE DATE OF APPLICATION SHALL NOT BE ROUTINELY RECOMMENDED FOR LICENSURE. SUCH INDIVIDUALS SHALL ROUTINELY BE DENIED AND REFERRED TO THE COMMISSION FOR A HEARING ON THEIR APPLICATION.
2. APPLICANTS LISTING AN ARREST OR ARRESTS WITHIN THIS 10 YEAR PERIOD SHALL BE REQUIRED TO PROVIDE DOCUMENTATION AS TO THE DISPOSITION OF SUCH ARRESTS, i. e., DISMISSAL, PRETRIAL INTERVENTION, DOWNGRADE, ETC.
3. APPLICANTS LISTING A CONVICTION MORE THAN 10 YEARS PRIOR TO THE DATE OF APPLICATION SHALL BE ROUTINELY RECOMMENDED FOR LICENSURE UNLESS THE CONVICTION PERTAINS TO THE FOLLOWING CRIMES:
(Please note that the general descriptive term for each crime has been utilized. Recent changes in New Jersey's Criminal Code have done away with some of the more general terminology while keeping the gist of the crime the same. For ease of reference, the New Jersey term is included in parenthesis. Any questions should be resolved by referring the individual to the Commission for a hearing on their application.)
 - a) TREASON (No New Jersey equivalent)
 - b) MURDER IN THE FIRST DEGREE (Murder 2C:11-3)
 - c) MURDER IN THE SECOND DEGREE (Murder 2C:11-3)
 - d) VOLUNTARY MANSLAUGHTER (Manslaughter 2C:11-4)
 - e) ARSON (Arson 2C:17-1, include also, causing or risking widespread injury or damage and criminal mischief of the third degree. 2C:17-2 & 3.
 - f) KIDNAPPING (Kidnapping first or second degree 2C:13.1)
 - g) BOOKMAKING OFFENSES (Promoting gambling, third degree, and possession of gambling records, third degree, 2C:37-2 & 3.
 - h) BRIBERY (Bribery 2C:27-2, include also, threats and other improper influence, and compensation for past official behavior. 2C:27-3 & 4.



- i) ARMED ROBBERY (Robbery 2C:15-1)
- j) PURCHASE, SALE, OR POSSESSION WITH INTENT TO DISTRIBUTE A CONTROLLED DANGEROUS SUBSTANCE (No change)
- k) LOTTERY OFFENSES (Promoting gambling, third degree, and possession of gambling records. 2C:37-2 & 3)
- l) ATROCIOUS ASSAULT AND BATTERY (Aggravated assault 2C:12-1b)
- m) PERJURY (Perjury 2C:28-1)
- n) FALSE SWEARING (False swearing 2C:28-2)
- o) EXTORTION (Theft by extortion 2C:27-5)
- p) MISCONDUCT IN OFFICE (Official misconduct 2C:30-2, include also, speculating or wagering on official action 2C:30-3.
- q) TAMPERING WITH WITNESS OR INFORMANT THIRD DEGREE (2C:28-5 Tampering with or fabricating with physical evidence, third degree, 2C:28-6)
- r) AN ATTEMPT OR CONSPIRACY TO COMMIT ANY OF THE FOREGOING OFFENSES.

ANY SUCH INDIVIDUAL SHALL BE ROUTINELY DENIED AND REFERRED TO THE COMMISSION FOR A HEARING ON THEIR APPLICATION.

IT SHOULD BE UNDERSTOOD THAT THESE GUIDELINES ARE TO APPLY TO CRIMINAL VIOLATIONS ONLY AND NOT OTHER DISQUALIFIERS SUCH AS CONSORTING, FISCAL IRRESPONSIBILITY, VIOLATION OF RACING RULES OR CONDUCT DEEMED DETRIMENTAL TO THE BEST INTERESTS OF RACING.
