(Attached hereto is a plan showing the location of the above described buildings on the premises herewith involved, together with the location of track, parking places for automobiles and such railroad or

bus terminals as may be constructed. Also, attached hereto architect's sketch of buildings and plans and specifications for the construction of the same and for the construction of the track.)

The said plans and specifications must contain the following minimum requirements which are herewith given as a guide:

- (a) The race track shall be of a mile in circumference of standard regulation.
- (b) The grandstand and clubhouse shall be built of structural steel and concrete, and of the latest type of fireproof construction.
- (c) The grandstand and clubhouse must accommodate a minimum of 20,000 people inclusive of any box seats and restaurant facilities and the buildings so constructed that future additions as to seating capacity can be so accommodated. Executive offices, racing officials' offices and attendant's operation department, jockey rooms, etc., and all other offices may be located under the grandstand in the mezzanine floor and ground floor. If any additional buildings are constructed, they shall be of same fireproof construction as specified for grandstand and clubhouse.
- (d) The minimum amount of box stalls required shall accommodate 1500 horses and 20 additional shall be erected in the paddock. Each row of stalls shall have sanitary toilet facilities and showers, for the use of stable employees. These facilities may be a part of stall buildings or separate buildings, adjacent to each row of stalls. All stalls shall be of a standard size, properly ventilated, fully sprinklerized and equipped with sufficient electric light.
- (e) There shall be a recreation building for the use of the help of racing stables, conveniently located and of suitable size for a lounge room with toilet facilities, equipped with library and reading matter, games and other forms of amusements.
- (f) There shall also be a suitable size kitchen and restaurant for the help of racing stables, size of building not to be less than 60 x 150 feet.
- (g) Parking space to be provided for a minimum of 10,000 cars.
- (h) There shall be a suitable office or offices provided for the State Racing Commission with all sanitary conveniences in such size and location as determined by the State Racing Commission.
- (i) There shall be forensic testing facilities providing for equine forensic analysis in such size, location and with such

appurtenances as determined by the State Racing Commission.

35. The applicant agrees if a permit is issued to abide by and comply with the provisions of Chapter 17 of the Laws of New Jersey 1940 and any rules and regulations heretofore or hereafter promulgated by the New Jersey Racing Commission.

36. The applicant agrees that if a permit be granted, all buildings and portions of buildings erected or to be erected on the premises here involved may be inspected by the New Jersey Racing Commission and

their duly authorized agents, servants or employees.

- 37. The applicant agrees that if said permit is granted and the buildings proposed to be erected and the track have not already been constructed, that such construction shall be subject to the approval and inspection of the New Jersey Racing Commission and to that end further agrees that the said New Jersey Racing Commission, its agents, servants or employees, shall have access to the same during construction, and further agrees to so construct in strict accordance with such plans and specifications as may hereafter be approved by the New Jersey Racing Commission and to pay for the cost and expense incurred for the study and approval of the plans and specifications and inspection of the construction by said New Jersey Racing Commission.
