Department administrative rules at N.J.A.C. 8:33C-2.8 provide for a formula that is required to be used in the determination of the need for bassinets that must be utilized in the CN process. As the formula utilized obsolete data and is no longer collected, the Department determined in planning for the 2019 CN Call to utilize another formula developed by examining the occupancy and utilization numbers for bassinets from existing providers in each county. However, because existing rules at N.J.A.C. 8:33C-2.8 set forth a specific formula that must be used to determine the need for this service, the decision to utilize a different formula was made in error, and the Department did not complete the review process.

The Department is in the process of examining and reevaluating the rules and intends to develop new standards for determining the need for intermediate and intensive NICU bassinets. As this process cannot be completed in time to accommodate the January 2, 2024 scheduled call, the call is canceled.

Pursuant to N.J.A.C. 8:33-4.1(a), the next scheduled call for regionalized perinatal services and maternal and child health services will be January 2, 2025. The Department will continue to monitor the utilization and availability of regionalized perinatal services and maternal and child health services and, should the need arise, issue a future call for these services before January 2, 2025.

The Department has determined that additional new specialized long-term care beds for pediatric care are not needed at this time.

On January 2, 2018, the Department issued a CN call for new specialized long-term care beds for pediatric care in the New Jersey Register at 50 N.J.R. 260(a). The Department conducted its review of the applications submitted and, on July 18, 2019, approved certificates of need for 17 specialized long-term care beds for pediatric care.

As of December 2023, 13 of the approved 17 specialized long-term care beds for pediatric care were implemented. Accordingly, it is necessary to cancel the call for specialized long-term care beds for pediatric care scheduled for January 2, 2024, to allow sufficient time for the implementation of these additional specialized long-term care beds for pediatric care.

The Department will continue to monitor the utilization and availability of specialized long-term care beds for pediatric care. Once all previous applications for new beds and services are implemented and should the need arise, the Department will issue a future call for these services. In accordance with N.J.A.C. 8:33-4.1(a), the next scheduled call for new specialized long-term care beds for pediatric care will be January 2, 2025.

In accordance with N.J.A.C. 8:33-4.1(a), the next scheduled call for new specialized long-term care beds for ventilator care will be January 2, 2025.
