INSTRUCTIONS FOR OBTAINING BOXER FEDERAL IDENTIFICATION

RENEWAL APPLICATIONS

Boxer must download & complete a Boxer Federal ID Application located on our website, https://www.nj.gov/oag/sacb/docs/sacb-Boxer-federal-ID-card-app.pdf, and return it via email (address sacblicensing@lps.state.nj.us) with a copy of his/her money order in the amount of \$25 made payable to: NJSACB, a headshot photo and scanned image of his/her driver's license or other government photo identification. The application and money order should also be mailed via regular U.S. mail to: NJSACB, P.O. Box 180, Trenton, NJ 08625-0180 (or by private carrier to: NJSACB, Station Plaza#4, 22 S. Clinton Avenue, Trenton, NJ 08609).

NEW APPLICATIONS (Pro Debut)

Boxer must complete the same process mentioned above. Additionally, a pro debut boxer also needs to provide an amateur book. Once we receive his/her emailed submission, we will contact the fighter to schedule a Zoom meeting, as all pro debuts must obtain their first Federal ID Number in person. Due to the Covid-19 pandemic, the NJSACB is not accepting any inperson visitors to the office until further notice. Therefore, we are issuing the Federal ID numbers for pro debuts via Zoom meetings.

<u>Please be reminded</u>: A Federal ID is not the same as a license to participate as a boxing contestant. All boxers must be licensed to compete/participate in an event held in New Jersey. Please wait to submit any license applications and accompanying documents, until such time as you are scheduled to participate in an event in New Jersey. The promoter will provide you with the information required to be licensed and your application will be submitted and paid through the promoter, who will deduct the payment from the fighter's purse amount.

Please be advised that no Federal ID cards or license cards will be issued until further notice, as our equipment to print the cards is inoperable. All Federal IDs are registered with BoxRec, so any commission will be able to view the status of a boxer's Federal ID Number.
