General Information

Who must file this Certification?

Any Non-Participating Manufacturer (NPM) whose cigarettes or roll-your-own tobacco (RYO) were sold in New Jersey during the preceding calendar year or who intends for its brands to be listed as compliant in the New Jersey Directory of Compliant NPMs.

Who Must Appoint an Agent for Service of Process?

Non-resident (out-of-state) and foreign NPMs who are not registered to do business in New Jersey are required to continually engage, without interruption, an agent in this State for acceptance of service of process.

Where an NPM's products are sold in New Jersey and the NPM fails to appoint an agent as required by N.J.S.A. 52:4D-1 et seq., the NPM shall be deemed to appoint the New Jersey Secretary of State as the agent on whom process may be served on its behalf. However, such appointment will not satisfy the condition precedent for having its brand families listed in the Directory of Compliant NPMs.

When is this Certification due?

The annual certification must be filed with the Attorney General no later than April 30 of each year for the preceding year's sales. An initial certification may be filed at any time.

Updates

If the NPM terminates the authority of an agent, the NPM shall notify the Attorney General at least 30 calendar days prior to the termination and provide proof of the appointment of a new agent at least 5 calendar days prior to the termination.

If the agent terminates an agency appointment, the NPM shall notify the Attorney General of the termination within 5 calendar days of the termination and shall include proof of the appointment of a new agent.

Specific Instructions

Part 1: Certification Year and Type of Certification

- Mark appropriate certification year. You must submit a separate certification for each year you are certifying.
- If "Other" is checked, enter certification year for which certification is being provided.
- Mark whether this is an initial (manufacturer is not currently

listed on the New Jersey Directory), annual (due April 30, 2025 for 2024 sales) or supplemental (change of information provided to the Attorney General) certification.

Part 2: Manufacturer Identification

Provide your company name, address, and phone, fax, FEIN numbers, person filling out certification and email.

Part 3: Manufacturer Status

- If you are registered to do business in New Jersey, **attach certification from New Jersey Division of Revenue, Business Registration.**
- If you are not registered to do business in New Jersey you must appoint an agent for service of process who is located within New Jersey, complete Part 4 and **attach current proof of appointment and availability of agent.**

Part 4: Agent Appointed for Service of Process

- Provide contact name and company of Agent appointed for service of process. Provide their physical (street) address as well as mailing address, phone and fax numbers, e-mail address and availability.
- Availability of Agent: normal business hours during which the agent is available at the address provided for the purpose of service of process.

Part 5: Manufacturer Certification

The authorized designee executing the certification must be an officer, principal, director or other authorized representative of the manufacturer. The authorized designee's name and title must be legibly printed and **the signature must be notarized.**
