13	Please state this program's statement of impact.	According to the New Jersey Office of the Attorney General, there were 145 suspected overdose deaths in Union County in 2021. That number declined significantly in 2022 to 114, a promising indication that the network of government and community organizations working in coordination to address the opioid crisis have made progress in doing so. However, 114 deaths are still 114 too many, and more than double the number of overdose deaths in the County a decade ago. Naloxone administrations are also on the rise, with 857 administrations in 2022. Harm reduction efforts, including dramatic expansion of the availability of naloxone, fentanyl test strips, and harm reduction services, are saving lives. Approximately 2,000 Union County residents access treatment in a NJ licensed treatment facility each year, vital to the stability and success of long-term recovery outcomes. According to the 2020-2023 Union County Comprehensive Plan for the Organization and Delivery of Alcohol and Drug Abuse Services states, - Approximately 64% of community members surveyed in the Union County Substance Use Questionnaire identified transportation as a barrier to treatment - Transportation is frequently cited


