Camden County's opioid abatement fund spending is focused on targeted, evidence-based programs aimed at reducing gaps in treatment and increasing recovery support services which align with the five key areas outlined in Camden County's Opioid Strategic Action Plan, including Prevention/Education, Early Intervention, Treatment, Recovery Supports, and Data Analysis.

The Camden County Prosecutor's Office, the Camden County Police Department, the Camden County Department of Health & Human Services, and the Camden County Board of Commissioners' Addiction Awareness Task Force all share input received from members of the public who are impacted directly or indirectly by the opioid crisis in our communities. The opioid abatement programs funded by Camden County are borne out of many years of meetings and conversations with key informants. Those meetings have included school superintendents, mental health and addiction professionals, law enforcement personnel, persons in recovery, the Local Advisory Committee on Alcohol and Drug Abuse, and the Camden County Opioid Advisory Committee.

The program offers a year-long calendar of events including softball tournaments, weekly golf and bocce ball, ice skating, movies, baking, ceramics, concerts, and trips to historic sites. These activities create opportunities for connection, joy, and healing—experiences that many participants would not otherwise have access to in a relaxed and supportive setting. The R.E.A.L. program also entails a broader quality-of-life services initiative which specifically targets the legal and social barriers that often prevent individuals in recovery from fully reintegrating into society.

It also empowers participants through legal and reentry services that address systemic barriers to long-term recovery. To measure impact, R.E.A.L. tracks attendance, collects participant surveys, and gathers feedback to assess changes in emotional well-being, social connection, and personal growth. Legal service outcomes are monitored through successful expungements, employment support, and housing stability. Testimonials and community impact reports help capture the broader effect of the program, ensuring it remains responsive, effective, and transformative.

By combining structured physical activity, social engagement, and legal empowerment, the program creates a supportive environment that promotes long-term recovery and emotional stability.</p> <p>Physical Activity as a Therapeutic Tool: Regular exercise is widely recognized as an evidence-informed strategy for managing symptoms of opioid withdrawal, depression, anxiety, and stress. Physical activity increases endorphin levels, improves mood, and enhances emotional regulation—key factors in reducing relapse risk and supporting mental health.</p> <p>Social Connection and Peer Support: Isolation is a major contributor to relapse and mental health decline. R.E.A.L. combats this by fostering community through team sports, group outings, and inclusive events. These activities build trust, reduce stigma, and promote healthy relationships, aligning with SAMHSA’s recovery support principles.</p> <p>Trauma-Informed and Stigma-Free Environment: All programming is delivered in a judgment-free setting that acknowledges the impact of trauma and prioritizes emotional safety. This approach supports individuals with co-occurring conditions by reducing barriers to participation and encouraging open engagement.</p> <p>Legal and Reentry Support Services: Through its partnership with the Volunteer Up Legal Clinic, R.E.A.L. addresses social determinants of health that often exacerbate substance use and mental health challenges. Services such as expungement, eviction diversion, and financial planning reduce stress and increase access to employment, housing, and healthcare.</p>

	5a) If yes, please explain:	<p>Outreach efforts are conducted on a twice weekly basis by Camden County Police Department Community Outreach Officers in partnership with the Center for Family Services, Camden County Health First, and local agencies to raise awareness about addiction services and available alternatives to substance use. These engagements focus primarily on transient populations throughout various neighborhoods in Camden City, and play a vital role in educating community members, reducing stigma, and increasing visibility around local treatment options. During this cycle, 34 individuals inquired about substance use treatment; 49 walked into Police headquarters seeking assistance; and 10 were referred directly to immediate treatment services. Individuals who requested substance abuse treatment were transported by CCPD officers to the Living Proof Recovery Center for intake and further support.</p>

	5a) If yes, please explain:	This program supports individuals experiencing homelessness by providing on-site recovery coaching, harm reduction tools, and connections to treatment, helping to reduce overdose risk and promote pathways to long-term recovery. Certified Peer Recovery Specialists (CPRS) circulate through three partner shelters, offering mentorship, recovery support, and direct linkage to care. This service increases treatment engagement and stability for individuals experiencing homelessness. The three partnered shelters are specific to: beds for veterans, beds for those with medical needs, and women and children. During this reporting cycle, CPRS engaged with 129 shelter guests, enrolled 17, and linked the enrolled individuals to 16 treatment connections.
