As a first step, a survey will be disseminated to the public to garner their input (translated into other languages as necessary) and the county will engage in a public education/awareness campaign as well as a provider capacity assessment. The goal is to educate the public on the dangers of opioids, prevent or mitigate the misuse of substances, educate residents about available resources and supports, minimize barriers that limit access to services by ensuring the basic needs of Hudson County residents are met, ensure that socioeconomic status, education and access to legal services are not barriers to recovery and support the existing infrastructure of service providers that already exist in the County.

Naloxone trainings are provided to professionals including educators, school faculty, nurses, EMS, law enforcement, and SACs with facilitators certified though Overdose Lifeline. Law enforcement officers have also been trained in operational readiness for addressing opioid use disorder and co-occurring conditions. When appropriate, referrals are made for evidence-based treatment to ensure a comprehensive and integrated approach.
