Therefore, we have brought in speakers to the youth, their parents and the elders to teach them about opioids and their dangers. Additionally, we have been running programs for teens and will continue to run programs for other age groups, where we are educating them about Opioids and then teaching them coping skills to help them deal with stress, anxiety and depression. We have ordered large amounts of Opioid focused educational materials to display and disperse at tabling events. Finally, we have been addressing and support those that have already been the victims of the negative impact of opioids. We are paying for their defense attorney for the Blue Cares program. We have also awarded a bid to a treatment and recovery center to provide treatment for those that are uninsured and those that are underinsured.
