10	Please share brief information on your subdivisions overarching goals and values to provide context for this year's spending decisions	Our subdivision's overarching goals focus on prevention, education, and community engagement to reduce and prevent opioid misuse. We value evidence-informed strategies and collaborative planning that reflect the needs of our residents. This year's spending decisions supported these goals by expanding our Med Drop Disposal Awareness Campaign. We distributed DisposeRx and Deterra pouches for at-home medication disposal, introduced medication organizers to encourage safe storage, and continued sharing public education materials building on prior efforts like informational magnets for the local Medication Drop Box. We also purchased tools and products for the Law Enforcement Against Drugs (LEAD) program at the middle school, supporting early prevention education. In addition, we purchased brochure holders to display opioid misuse resource materials, which will be acquired in a future cycle to further enhance public access to prevention information. All spending decisions were guided by a multifaceted committee, including members of the Health Department, Municipal Alliance, Public Health Nursing, and community residents. Continued discussion will ensure alignment with our prevention goals of reducing and preventing opioid misuse.
