This year, our funding allocation continued to work on our Law Enforcement Assisted Diversion abilities for those entering the criminal justice system. By expanding our existing technological infrastructure to target pharmacy crimes, especially prescription fraud, pharmacy burglaries, and crimes involving prescription opioid abuse, our agency focused on placing ALPR systems at major chokepoints in the Township that are near major pharmacies (including ones named in the Settlement agreement) to help identify those individuals perpetrating crimes related to opioids and divert them from the criminal justice system to meaningful rehabilitative drug court options focused on recovery instead of incarceration. Similarly, we focused on offering post-arrest treatment for those individuals driving under the influence of drugs - something that can only be detected by a full drug recognition expert (DRE) evaluation, including utilization of a breath testing device to exclude the possibility that the influence is caused by alcohol use. Those individuals arrested for driving under the influence of drugs can be immediately connected with the Helping Hands 365 program, getting treatment and connection with counselors 24/7. We also increased our "drug take back" capabilities at target-rich locations including senior citizen centers and pharmacies. Lastly, we held 2 public assemblies at the Cranford High School with presentations on substance use disorder, mental health, coping mechanisms, and overall wellness during challenging and stressful phases of a teenager's life in an effort to proactively connect counselors and presenters with a target-rich, young population of viewers.

Utilizing local, County and State crimes trend data and experiences within our juridiction involving pharmacy burglaries and motor vehicle pursuits stemming from pharmacy crimes, the Cranford Police Department keyed in on a patteron of criminal activity that involved prescription opioid abuse and its black market. Additionally, but expanding our agencies capabilities to have four certified and trained drug recognition experts (DRE), the purchase of the Alcotest expands our capability of running tests, and determining whether an individual is actively under the influence of an opioid, prompting immediate treatment options through the Helping Hands 365 program. Lastly, our goal has been to expand in-school education regarding substance use disorder, handled by the school counselors.

The overarching goal of the City of Elizabeth - Department of Health and Human Resources, is to significantly reduce overdose fatalities while providing assistance to recovery support services for individuals who suffer from Substance Use Disorders (SUDs) and their family members who desire it.

A second overarching goal is to assist individuals of color. According to the 2020 US Census the population of Elizabeth is 135,407. 65.3% are of Hispanic descent, 18.7% is of African American decent. According to the New Jersey Office of the Attorney General, when it comes to overdose deaths in New Jersey, "Blacks rose 256%, and death among Hispanics rose 189%, compared to a 38% increase among the state's white population. Within the city are 5 zip codes: 07201, 07202, 07206, 07208, 07114. Zip code 07114 has the highest percentage of Blacks, but the lowest percentage of Hispanics. Zip code 07206 has the highest percentage of Hispanics and the second lowest percentage of Blacks. Zip code 07201 has neither a high rate of Blacks nor Hispanics but has the highest rate of overdose incidents. That is most likely because it is the main transportation corridor where buses stops, and the local train station is located. In can be argued that this location is where most drug activity tasks place. Our core values are built on equity: a belief that everyone should have the opportunity to reach their maximum potential. That opportunity comes through equal access to education, healthcare, employment, housing, and other forms of assistance that could potentially break cycles of recidivism, relapse, poverty, and negative internal/external environmental conditions that hinder individual progress.

How did you decide the best way to use the opioid abatement funds your subdivision received this reporting year? For example, did you rely on evidence-based or evidence-informed practices or strategies, the list of Opioid Remediation uses, a needs assessment, a strategic plan, or an epidemiological analysis? If yes, please explain.

In 2019, the City of Elizabeth was awarded an Overdose Fatality Review Team (OFRT) grant by the New Jersey Department of Health (NJDOH). This grant aids in the development of a task force referred to as the Elizabeth Overdose Fatality Review Team (E-OFRT). It involves a case review process that generates information about decedents and their interaction with our services and systems. The information gathered is used to craft programs and policy recommendations in Elizabeth and Union County that address Substance Use Disorders (SUD's) and support recovery services to prevent similar deaths. The information shared at an E-OFRT meeting by participating public, private, non-profit and religious organizations is used to create a profile of the decedents life and interaction with various support systems to identify:

- 1) Missed opportunities,
- 2) Gaps in the system and,
- 3) Potential interventions.

The goals of the E-OFRT are,

- 1) Prevent future overdose deaths city and county wide,
- 2) Promote changes at the organization, community, or systems level like changes in partnerships, policies and practices that can contribute to the prevention of opioid overdose deaths,
- 3) Improve coordination and collaboration among agencies,
- 4) Identify the specific risk factors that put individuals at risk for drug overdose within a particular jurisdiction and,
- 5) Formulate recommendations for change. The policy and programmatic recommendations are referred to the City of Elizabeth Department of Health and Human Services for implementation (where applicable).
