NEW JERSEY STATE PAROLE BOARD PROMOTES THREE OF ITS DEDICATED MEMBERS TO CAPTAIN

Agency Captains Bring a Total of More Than Six Decades of Knowledge, Leadership Experience and Passion to the Areas of Parole and Reentry

TRENTON, NJ, January 13, 2020 — Earlier today, three New Jersey State Parole Board commanders were promoted from the rank of lieutenant to captain during a swearing-in ceremony held at the agency's central office in Trenton.

Captains Chris Carlini, A.J. Falbo, and Brandon Rose all took the Oath of Office and were sworn in by New Jersey State Parole Board Director of Legal Support Robin Stacy.

New Jersey State Parole Chairman Samuel J. Plumeri, Jr. said "This agency is not only extremely fortunate but very excited that Captains Carlini, Falbo, and Rose will serve in their respective capacities. All three captains have illustrated inherent professionalism, expertise, and an intimate knowledge of parole supervision and the reentry process. As this agency continues its critical mission, I am confident that these capable commanders will help guide the more than 300 officers who work tirelessly to ensure public safety within our communities."



"Our three new captains have a combined total of 65 years of parole law enforcement experience and are accomplished, demonstrated leaders," said New Jersey State Parole Board Executive Director Steven Tallard. "Like many others at the State Parole Board, I look forward to the many positive contributions that Captains Carlini, Falbo, and Rose will make that will invariably help guide and support our valued officers and commanders."

Captain Carlini, who has been with the State Parole Board since 2000, is a graduate of the University of Delaware where he received a B.A. in Criminal Justice. He began working for the State of New Jersey in 1996 as a probation officer in Camden County. After graduating from the New Jersey State Parole Academy in Sea Girt, Captain Carlini joined the agency as a parole officer, before eventually being promoted to sergeant, and then lieutenant. He resides in Burlington County.

Hired in January of 1997, Captain Falbo joined the State Parole Board as an officer recruit where he was assigned to District Office #1 in Passaic. He was promoted to sergeant six years later in 2003, then promoted to lieutenant in 2015. Captain Falbo worked in two additional district offices and assigned to the agency's Community Programs Division, Investigations Management Office, and the New Jersey State Police Internet Crimes Against Children Task Force. He has also served with the Division of Parole Honor Guard. Additionally, Captain Falbo is a firearms instructor and adjunct trainer with the agency's training unit, which he began teaching in 2004.

Captain Falbo received his B.A. in Criminal Justice with a minor in Computer Sciences from Norwich University in Vermont. He is also a graduate of the New Jersey State Association of Chiefs of Police and completed courses presented by West Point Command and Leadership, as well as an FBI Law Enforcement Executive Development Command Leadership course.



A 23-year veteran with the New Jersey State Parole Board, Captain Rose has served as an officer and commander with the agency, working in district offices located in Jersey City, Trenton, and Red Bank. At these locations, he managed members on the State Parole Board's sworn side as a lieutenant. Additionally, he worked at the agency's Office of Interstate Services in Trenton. Captain Rose received his B.A. in Law & Justice from The College of New Jersey, when it was previously known as Trenton State College. He is also a proud graduate of

the New Jersey Chiefs of Police West Point Command and Leadership Program and is designated as a certified public manager through a joint State of New Jersey-Fairleigh Dickinson University program. Captain Rose is a resident of Ocean County.

Captains Carlini, Falbo, and Rose will help manage the various parole law enforcement needs at the New Jersey State Parole Board's district offices.

The New Jersey State Parole Board (SPB) is committed to promoting public safety, utilizing effective methods to aid supervised offenders in reentering society, and to reduce the recidivism of offenders while addressing the needs of crime victims. As required by law, appointed parole board members and staff conduct approximately 13,500 hearings per year, solicit input from victims, and decide upon parole matters. Nearly 400 sworn SPB parole officers supervise more than 15,500 offenders and act as New Jersey's primary law enforcement agency responsible for sex offender supervision. Additionally, SPB officers are also active partners with a variety of federal, state, and local law enforcement agencies and task forces. Finally, the SPB's Community Programs Unit partners with government, non-profit, and private agencies to connect former inmates with vocational, mental health, and related services.
