# Combined Sewer Overflow (CSO) Construction Related Activities Reported to PVSC for the Third Quarter 2016 July 1, 2016 through September 30, 2016

#### Bayonne – as reported by Bayonne Municipal Utilities Authority ("BMUA")

- SCADA Upgrades to 5th Street, 22nd Street, Avenue J, MOT 1A, 1, 2, and 3 Pumping Stations; currently 5th Street, 22nd and North Street stations are being installed and will be programmed in 2016. Avenue J, MOT 1A, 1, 2 and other pump stations are scheduled to be started in and completed by end 2016.
- Bar Screens at Oak Street Pump Station- Bar Screens 1 and 2 have been retrofitted with new bars, brakes, motors and guides. New guide cartridges fabricated, installation is ongoing and should be completed mid 2016; completing punch list items. Storm water bar screen scheduled for 2017.
- Backflow preventers at each pump station to be evaluated, tested and if necessary replacements installed. Applied for Physical Connection Permit amendment to include these units; awaiting NJDEP approval.
- Raw water pump #3 impeller at Oak Street repaired and running normal.
- New wiring at control panel, Avenue J pump station.
- New comminutor motor installed at MOT 2.
- Vacuumed and flushed Avenue J wet well.
- Block heater replaced at MOT 3 generator.
- Completing punch list items at Oak Street Pump Station Bar Screen rehab project.

## <u>Harrison – as reported by the Town of Harrison</u>

- As part of the redevelopment work being performed along Angelo Cifelli Drive, the contractor installed a new sanitary, storm and combined sewers in the roadway between South 2<sup>nd</sup> and South 3<sup>rd</sup> Streets.
