**Content Note**

The executive clemency files included in this series relate to petitions to the governor for pardon, commutation of sentence, medical commutation of sentence, remission of fine (rare), and waiver of the rule requiring that one year of a sentence be served before application for clemency. The files normally contain memoranda giving recommendations of the Board of Pardons and the Counsel's Office, a copy of the pardon or commutation if granted, and related correspondence.

**RESTRICTION NOTE:** Pursuant to Governor Kean's access guidelines dated 5 March 1990, executive clemency records are to remain sealed from use by the general public until 21 January 2015. Exception to this rule may be granted only by express written permission from Governor Kean or his legal assigns.
