Content Note

This series consists of portrait photographs of court officials collected by the Administrative Office of the Courts (AOC) during the period 1973-1979. Most were used in a circa-1974 edition of the *Pictorial Directory of the New Jersey Judiciary* (distributed as a supplement to the *New Jersey Law Journal*). Included are formal and informal (i.e., snapshot) portraits of judges and administrative staff members of the state and county courts. The collection is arranged (as was the *Directory*) by court, in the following order: Supreme Court, Superior Court, county courts, district courts, juvenile and domestic relations courts, and lastly the AOC. Within each court, the portraits are arranged alphabetically by the name of the official, regardless of title. The photographs are mostly B&W prints and range in size from 2"x3" to 8"x10". Unless otherwise noted, each file includes one photograph. *NOTE:* A copy of the *Pictorial Directory*, along with various lists and notes which were used to compile it, are included at the end of Box 3. A number of portraits appearing in the *Directory* are missing from this collection .
