Institutional History

In November 1970, Governor Cahill created the Welfare Study Commission to research and provide advice on methods to control the state's rapidly rising welfare costs. In the previous four years, the state's annual public assistance budget had risen from \$59 million to \$216 million, with an additional \$75 million increase projected for Fiscal Year 1972. The commission consisted of thirteen men, representing various cities and counties throughout the state. The governor appointed Martin L. Haines as chairman, Richard Van Plaat as vice-chairman, and Thomas E. Hitselberger as executive secretary.

Pressed for time, the committee researched and produced a report for the governor by mid-January so he could incorporate the recommendations into his budget report to the legislature which was due in early 1971. The report consisted of the commission's philosophy and recommendations for correcting welfare programs, such as the Work Incentive Program (WIN) and the Assistance to Dependent Children Program (ADC), in order to prevent abuse and reduce expenditures, without jeopardizing the poor.

Several members of the commission continued to serve the governor after this report, as the Welfare Advisory Council. The council held its first meeting sometime in early 1971. It was apparently phased out in 1972.

Content Note

The records of the commission and council, kept by Thomas Hitselberger, consist of correspondence, reports of the commission, minutes of meetings, public assistance statistics, and reports of studies done by accounting firms hired by the commission. The files are arranged alphabetically by subject.
