New Jersey Dr. Martin Luther King, Jr. Commission: 2026 MLK Holiday Commemorative Mini Grant

The New Jersey Dr. Martin Luther King, Jr. Commission is offering mini-grants to support commemoration of Dr. Martin Luther King, Jr., and his work & legacy, on or around the Martin Luther King, Jr. Day holiday on January 19, 2026.







The Commission will award mini-grants to community organizations and programs to highlight and commemorate Dr. King on or around the 2026 MLK Holiday. Funding based on the reach of the program; grants up to \$1000 for local programs; \$2500 for regional programs; and up to \$5000 for statewide programs. NOTE: Priority will be given to events that incorporate observation or commemoration of the 250th anniversary of the signing of the Declaration of Independence and/or New Jersey's pivotal role in the founding of our country.

We are seeking applications of up to 3 pages, including a budget, that will propose events or programs that might include: Community Service or Clean-up; Presentation of archival material/film: Arts event; Civil Rights Discussion/Roundtable' Interview vets of the Civil Rights Movement; Sports Event; etc.

APPLICATION DEADLINE: 9:00 AM on Monday, October 6, 2025

 - Description of the program or event
 - Date of the program (all events must be completed by 02/17/2026)*
 - Location or venue
 - Lead organization
 - Point of contact information
 - Expected audience
 - Anticipated number of participants
 - Anticipated outcome(s)
 - List of Partners--if applicable
 - o **BUDGET:** (1 page). NOTE: No direct gifts or gift cards can be purchased with this grant.

To receive funding, grantees <u>must</u> be either registered in <u>NJStart</u> or submit a completed <u>NJ Non-procurement W9</u> as directed on the form. Please direct any questions about these processes to the contacts listed on the forms.

WHO IS ELIGIBLE:

Eligible agencies include public or private non-profit organizations (501C3 only), community and faith-based organizations; American or NJ Indian Tribal communities: local education agencies, charter schools and institutions of higher education; local, county or state government; labor organizations; and partnerships or consortia consisting of the aforementioned.

ABOUT THE AWARD:

- 1. Awards will be announced early November 2025.
- 2. Funds will be made available by December 31. Pending grantee compliance with terms.
- 3. All events must be completed by February 17, 2026
- 4. Funds must be spent by March 17, 2026
- **5. A final report** (minimum 1 page), expenditure report and photographs are due to the MLK Commission by **March 31, 2026 by 5PM**

All events will be listed on the New Jersey Martin Luther King, Jr. Commission website.

The MLK Commission will provide commemorative items for the events
