RE: Center Extension Recommendation

DATE: May 13, 2022

With the execution of Executive Order No. 292 (2022) ("EO 292"), Governor Murphy revoked the Public Health

Emergency but maintained the State of Emergency. The State Planning Commission Centers were included in the previous executive order that extended the Center designations until the Public Health Emergency was revoked; however, EO 292 indicates that all extensions remain as long as the State of Emergency remains in effect.

EO 292 further allows the rule-making body to modify the extensions, EO 292, paragraph 6, and toward that end, the following staff proposal is put forward for approval.

There are 89 out of the total 94 municipalities whose Centers and/or Plan Endorsement remain extended. Five of the original 94 municipalities have been endorsed through the Plan Endorsement Process (Millstone, Vernon, Allentown, Upper Township, and Galloway).

The 89 Centers that remain breakdown as follows (see below for the list of municipalities):

- 22 municipalities have sent written confirmation that they do not intend to pursue endorsement and/or center designation
- 11 have not responded to several requests regarding their intention to pursue endorsement
- 11 have indicated they wish to pursue but there has been no meaningful attempt to pursue endorsement
- 45 are in some stage of the process and are meaningfully engaged in pursuing endorsement

RECOMMENDATION

It is recommended that the State Planning Commission take the following actions:

 Terminate the status of the 22 municipalities that have sent written confirmation that they do not intend to pursue endorsement and/or center designation, via resolution at the next Commission meeting. Include

- those additional municipalities that indicate the same intention via written confirmation received up to the date of the action.
- Declare a Center endorsement deadline of March 31, 2023, for the remaining 67 municipalities via resolution at the next Commission meeting.

ACTION PLAN

- The Office of Planning Advocacy will send to all 89 municipalities a letter via certified mail providing notice of the proposed action and include a call to action to respond if their intention is different than what we indicate as their status. Three draft letters are proposed, based on the status of the municipality (see attached drafts).
 - o Written confirmation of the intent to abandon the process
 - Lack of meaningful action
 - o Currently working in good faith
- Present to the Commission for approval a resolution that:
 - Terminates those that do not intend to pursue endorsement
 - o Declares the termination date of March 31, 2023, for the remaining municipalities
 - Authorizes publication of the Notice of Rule Modification in the New Jersey Register

HISTORY/RELEVANT FACTS

- The relevant Centers were extended via various permit extension acts and then through Executive Order No. 103 (2020) ("EO 103") declaring the Public Health Emergency and the State of Emergency due to the COVID-19 pandemic on March 9, 2020 (note that the Public Health Emergency and the State of Emergency are two different declarations).
- On March 4, 2022, Governor Murphy signed EO 292 which terminated the Public Health Emergency but maintained the State of Emergency and maintained the extensions. However, paragraph 6 of EO 292 authorizes revocation or modification of those extensions:
 - "All actions taken by any Executive Branch departments and agencies in whole or in part to respond to the Public Health Emergency presented by the COVID-19 outbreak, and extended pursuant to Executive Order No. 281 (2022) and attached in the Appendix thereto, including but not limited to any Administrative Orders, Directives, and Waivers, remain in full force and effect pursuant to the Disaster Control Act, N.J.S.A. App. A:9-33 et seq, until revoked or modified by the department or agency head, or until the State of Emergency is no longer in effect, whichever is sooner, except that any Administrative Order, Directive, or Waiver extended pursuant to Executive Order No. 281 (2022) that was revoked after the effective date of Executive Order No. 281 shall not remain in full force and effect." (emphasis added).
- The status of expiring Centers has been communicated to the affected municipalities on numerous occasions
 via letters from the Executive Director as well as interactions between the planners and the municipalities.
 There are 11 municipalities that have not responded to numerous requests.

- After review and consultation, the Executive Director recommends that this action be completed via resolution. This recommendation is based on the fact that the original modification to N.J.A.C. 5:85-7.21(g) was done via resolution (2020-07), under the authority granted by Executive Order 103.
- While there was the consideration of beginning the formal rulemaking process, the Executive Director does not recommend this course of action because:
 - The actions via resolution would only be negated if the State of Emergency is revoked. If that happens, the expirations would revert to the existing rule, which has an expiration of June 30, 2020.
 - It is unlikely that the State of Emergency will be revoked before March 31, 2023; but if it is revoked, the result would be as follows:
 - For the municipalities that would have immediately terminated centers based on this recommendation, there is no difference in the result;
 - For the remaining municipalities with a recommended deadline of March 31, 2023, Centers will be terminated as of the date of the revocation of the State of Emergency. This risk is minimal as the deadline is less than 10 months away.
 - A rule-changing process could take an extended period and would likely become effective very close to the proposed deadline.
