RESOLUTION

WHEREAS, by approval of Resolution No. 88-005: Adoption of the State Commission By-laws on May 27, 1988, the State Planning Commission (the Commission) adopted by-laws to govern its procedures; and

WHEREAS, pursuant to Article Six of the Commission's By-laws, the Commission has created from its membership the Plan Development Committee to assist with the development of the State Development and Redevelopment Plan; and

WHEREAS, the Commission has determined to adopt a schedule of the regular meetings of the Plan Development Committee of the State Planning Commission to be held by the Commission during 2025.

NOW THEREFORE BE IT RESOLVED that the Commission hereby adopts the following schedule of dates for the Plan Development Committee regular meetings during 2025: Wednesday, January 8, 2025; Wednesday, February 5, 2025; Wednesday, March 5, 2025; Wednesday, April 2, 2025; Wednesday, May 7, 2025; Wednesday, June 4, 2025; Wednesday, July 2, 2025; Wednesday, August 6, 2025; Wednesday, September 3, 2025; Wednesday, October 8, 2025; Wednesday, November 5, 2025; Wednesday, December 3, 2025.

BE IT FURTHER RESOLVED that in adopting the schedule set forth above, the Commission cannot at this time, identify the specific location for each of its regular scheduled meetings for 2025 and accordingly authorizes the Chairman of the Commission to determine the location of each such meeting and the time at which each such meeting shall commence and to provide notice of such location and time when available.
