RESOLUTION

ADOPTING THE REGULATION AMENDING N.J.A.C. 5:85-7:21 AND EXTENDING THE PERIOD OF CERTAIN PLAN ENDORSEMENTS AND CENTER DESIGNATIONS

WHEREAS, the State Planning Commission has been created pursuant to the State Planning Act, N.J.S.A. 52:18A-196, et seq.; and

WHEREAS, N.J.S.A. 52:18A-203, et seq., of the State Planning Act authorizes the State Planning Commission to adopt rules and regulations to carry out its purposes including the preparation and adoption of a State Development and Redevelopment Plan; the undertaking of a cross-acceptance process in conjunction therewith; establishment of mapping classifications and the establishment of procedures to endorse municipal, county and regional plans that are consistent with the State Development and Redevelopment Plan; and

WHEREAS, the State Planning Commission has filed a rule proposal with the Office of Administrative Law for publication which was published in the in the New Jersey Register on March 4, 2019; and

WHEREAS, the rule proposal provided a 60-day comment period;

WHEREAS, the Commission has received a total of five comments regarding the rule proposal; and

WHEREAS, the Office for Planning Advocacy has reviewed all of the comments to the rule proposal and prepared the attached Summary of Public Comments and Agency Responses; and

WHEREAS, the proposed regulation provides that any endorsement of a plan, designation of a center, or other approval governed by subsections (a) through (f) of the State Planning Rules N.J.A.C. 5:85-7.21 with an expiration date on or before December 31, 2019 is extended to June 30, 2020; and
