N.J.S.A. 19:61-9 AUDITS OF ELECTION RESULTS

2021 GENERAL ELECTION

Audit Date: November 23, 2021

The Passaic County Board of Elections performed an audit consistent with the provisions of N.J.S.A. 19:61-9.

The General Election held November 2, 2021 was Vote-by-Mail, Provisional and Voting Machines. Current voting machines in the County of Passaic do have a verified voter paper trail.

Pursuant to the statute, if batches for each Legislative District were under 100, two batches were to be audited. If the batches for each Legislative District were 100 or greater then 2% of the batches in that district are to be audited. Passaic County is comprised of seven Legislative Districts. Legislative Districts 26th, 34th, 35th, 36th, 38th, 39th and 40th.

The Passaic County Board of Elections conducted a hand-to-eye count of the paper records for the General Election held November 2, 2021 for the following offices: Governor, State Senate, State Assembly, Surrogate, County Commissioners and Municipal Council where applicable.

Audit units were comprised of vote-by-mail ballots, provisional ballots and Voting Machines. 20 batches in total were audited.
