N.J. S. A 19:61-9 Audit of Election Results
2021 General Election

The Salem County Board of Elections performed an audit consistent with the provisions of N.J.S.A. 19:61-9.

The General Election was held on November 2, 2021, with an Early Voting Period held October 23-31, 2021. The election consisted of Vote-By-Mail, Provisional and Voting Machine ballots. The entire fleet of voting machines in Salem County utilize a voter verified paper audit trail reel to reel tape system.

Salem County is located entirely within the Third Legislative District.

The Salem County Board of Elections conducted hand-to-eye count of paper records for the General Election held November 2, 2021, for the following offices:
Governor, State Senate, State Assembly, County Commissioner and Municipal Council/Committee, where applicable.

Since Salem County has less than 100 election districts, two audit units were randomly selected in each audit category. Audit units were comprised of Early Voting Ballots, Vote by Mail Ballots, Provisional Ballots and Election Day Ballots. A total of 62 batches were randomly selected for audit as follows:

In each audit batch, the hand-to-eye was consistent 100% with the tally reports generated with the exception of Tabulator 182, Batch 1000. One vote cast for one Township Committee member on one emergency ballot was mis-entered resulting in 1 vote less for the single candidate in the contest. The audit results did not change the outcome of any race for any candidate.
