N.J.S.A. 19:61-9: AUDIT OF ELECTION RESULTS

2023 General Election

Audit Date: November 20, 2023

The Camden County Board of Elections (CC BOE) performed an audit consistent with provisions of N.J.S.A. 19:61-9.

The Camden County Board of Elections conducted a hand-to-eye count of the voter-verifiable paper records for the General Election for State Senate, General Assembly, Board of Commissioners, and one municipal race, where available. The additional municipal races, Board of Education, Fire Commissioner, and public questions were excluded from the audit.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot." Camden County is comprised of Three Legislative districts. Two units were chosen from Legislative District Four, seven units were chosen from Legislative District Five and 11 units were chosen from Legislative District Six.

Audit units included vote by mail ballots by municipality/ward that were received by November 13, 2023, with a timely postmark; provisional ballots by municipality/ward; votes cast during Early Voting on voting machines, and votes cast on Election Day voting machines. Tally sheets were prepared in advance of the audit for each municipality/ward.

The selected audit units are listed on the attached spreadsheet.

The audit units contained no discrepancies. Any paper ballot which contained an overvote for a contest was recorded as an overvote but did not count any votes. The audit did not tally undervotes. The ballot scanners use Intelligent Mark Recognition and Positive Target Recognition and Alignment Compensation technologies, to determine what ballot needed to be sent to adjudication computers for the final decision on voter intent.
