N.J.S.A. 19:61-9 AUDITS OF ELECTION RESULTS

2023 GENERAL ELECTION

Audit Date: November 20 & 21, 2023

The Mercer County Board of Elections (MC BOE) performed an audit consistent with the provisions of N.J.S.A. 19:61-9.

The General Election held November 7, 2023 was conducted with Nine (9) days of early voting using the Dominion ICX Ballot Marking Devices and ICP2 Tabulators w/ paper ballots, Vote-By Mail Ballots, Provisional Ballots, Emergency Ballots and Election day using Dominion ICX Ballot Marking Devices and ICP Tabulators w/ paper ballots.

Pursuant to the statute 2% of audit Units of the paper ballot batches for each Legislative District within Mercer County were to be audited. Mercer County is comprised of three (3) Legislative Districts; 14, 15 & 16.

The MC BOE conducted a hand-to-eye count of the paper records for the General Election held November 7, 2023 for the following offices: State Senate, General Assembly, County Executive, Sheriff, Board of County Commissioners and Mayor, Municipal Council and Municipal Committee.

Audit units were comprised of early voting ballots, election day machine ballots, vote-by-mail ballots, and provisional ballots. Based on less than 100 voting districts in Legislative Districts 14 & 16, 2 Units were required to be audited and in Legislative District 15, 3 units were required to fulfill the 2%.

In LD14, East Windsor, Hightstown, Robbinsville and Hamilton Twp, each Municipality hand to eye audit was 100% consistent with the scanned tally report except Hamilton Batch 81. When 1 ballot was being adjudicated for the office of General Assembly, the adjudicator thought there was an over voter between 3 candidates that was vote for 2. After a closer look, 3 candidates were filled in as votes, but 1 had an "X" through it. 2 candidates should have received an extra vote each.

In LD15, Ewing, Hopewell Boro, Hopewell Twp, Lawrence, Pennington, Trenton North, Trenton South, Trenton East, Trenton North and West Windsor, each Municipality was 100% consistent with the hand to eye count compared to the scanner tally report.

In LD16, Princeton, is was also was 100% consistent with the hand to eye count compared to the scanner tally report.

Lastly, we completed 3 Early Voting Site Tabulator audits in Ewing, East Windsor and Princeton and all 3 tabulators selected were 100% consistent with the hand to eye count compared to the scanner tally report.

Any paper ballot which contained an overvote for a contest recorded it as an overvote and the vote was not counted. If a name was not a valid voter for a contest, the vote was also not counted.
