N.J.S.A 19:61-9 AUDITS OF ELECTION RESULTS 2023 General Election Audit Date: November 20, 2023

The Morris County Board of Elections performed an audit consistent with the provisions of N.J.S.A 19:61-9.

The General Election held on November 7, 2023 was conducted using the ES&S Express Vote XL ballot marking device voting machine at the polls on Election Day and during the (9) days of Early Voting. The Vote-By-Mail and Provisional Ballots were also part of the audit.

Morris County is comprised of (4) Legislative Districts. Pursuant to the statute, based on the number of election districts in each Congressional District a random selection of 2% or at least (2) units/batches of all voting machines and paper ballot units/batches for each Legislative District were audited.
